The Liaquat and Dow Medical and Health Sciences Universities (Amendment) Bill, 2006 have been passed by the Provincial Assembly of Sindh on Wednesday, the 15th November, 2006 and assented to by the Governor of Sindh on Monday, the 18th December, 2006, is hereby published as an Act of the Legislature of Sindh.

to further amend the Liaquat University of Medical and Health Sciences Ordinance, 2001 and the Dow University of Health Sciences Act, 2004.

WHEREAS it is expedient to amend the Liaquat University of Medical and Health Sciences 2001 and the Dow University of Health Sciences Act, 2004, in the manner hereinafter appearing;

Preamble

It is hereby enacted as follows:-



- (1) This Act may be called the Liaquat and Dow Medical and Health Sciences Universities (Amendment) A ct, 2006,
- (2) It shall come into force at once.

Amendment of Single Ordinance VIII OF 2001.

- In the Liaquat University of Medical and Health Sciences Ordinance, 2001.
  - (i) In Section 13, for sub section (1), the following shall be substituted:-
    - "(I) The Minister of Health shall be the Pro-Chancellor of the University;
  - (ii) In Section 14, for sub section (I), the following shall be substituted:-
    - "(I) Any person having medical background shall be appointed Vice Chancellor by the Chancellor for a period of four years on such terms and conditions as the Chancellor may determine and shall hold office during the ple
  - (iii) In Section 16, for sub-section (I), the following shall be substituted:-
    - "(I) The Registrar shall be a whole time officer of the University and shall be appointed by the Syndicate on such terms and conditions as it may determine"; and
  - (iv) In Section 19, in sub section (I), for the words "Provincial Audit Department", the word "Syndicate" shall be substituted.

Amendment of Sindh Act X of 2004.

In the Dow University of Health Sciences Act, 2004.

- (i) section 11, shall be renumbered as sub section (1) of that section, and thereafter the following new sub section shall be added:-
  - "(2) Should the Chancellor be incapacitated acting as such due to absence or any other cause, the Pro-Chancellor shall exercise all the powers and perform all the duties of the Chancellor."
- (ii) in section 12, for sub-section (1), the following shall be substituted:
  - "(I) Any person having medical background shall be appointed Vice Chancellor by the Chancellor for a period of four years on such terms and conditions as the Chancellor may determine and shall hold office during the pleasure of the Chancellor.";
- (iii) in section 20, in sub section (2), for the words "Pro-Vice Chancellor", the words "Pro-Chancellor" shall be substituted; and

- (tv) in section 22, in sub section (I)-
  - (a) in clause (xi), the word "and" at the end shall be replaced by a semi colon; and
  - (b) in clause (xii), the full stop at the end shall be replaced by a semi colon and the word "and" and thereafter the following new clause shall be added:-

"(xiii) one alim and one woman of eminence not serving in any educational institution to be nominated by the Chancellor".
