Karachi, the 22nd December, 2006

NO PAS/LEGIS-B-15/2006. The Sindh Vocational Training Council Bill, 2006 have been passed by the Provincial Assembly of Sindh on Wednesday, the 15th November, 2006 and assented to by the Governor of Sindh on Monday, the 18th December, 2006, is hereby published as an Act of the Legislature of Sindh.

THE SINDH VOCATIONAL TRAINING COUNCIL ACT, 2006.

SINDH ACT NO. XI OF 2006

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 22nd December, 2006).

AN

to provide for the establishment of a vocational training council in the Province of Sindh.

WHEREAS it is expedient to provide for the establishment of a vocational training council in the Province of Sindh and for the matters connected therewith and ancillary thereto;

Short title and commencement

- It is heary 1. (1) This TACT may be called the Sindh Vocational Training Council Act 2006.
 - (2) It shall come into force at once.

Definitions.

- 2. In this "Act unless there is anything replugnant in the subject or context -
 - (a) "Board" means the F are established under section 6;
 - (b) "Chairman" mes, s the Chairman of the Council;
 - (c) "Council" means a Council established under section 4;
 - 1" means fund established under section 8;
 - overnment" means the Government of Sindh; 16
 - "Institute" means the Vocational Training Institute established under section 5:
 - (g) "prescribed" means prescribed by rules or regulations: and
 - (h) "rules or regulations" means rules or regulations made under this Act:

- Incorporation of 3. (1) Government may by notification establish a Council to be . called the Sindh Vocational Training Council.
 - (2) The Council shall be a body corporate having perpetual succession and a common seal with powers to acquire and hold property and shall sue and be sued by the said name.

Constitution of. the Council.

- 4. (1) The Council shall consist of not less than seven and not more than fifteen members as Government may by notification appoint.
 - (2) The Secretaries of Finance, Zakat and Ushr and Education Departments shall be the ex-officio members of the Council ther members shall be appointed from amongst the persons in the private sector in the field of as wife, agro-based industry, industry or a profession; anded that the number of members from the field of agriculture and agro-based industry shall not us less than year, five percent of the total number of the members of the Council.
 - (3) The Council may co-opt not more than four members.
 - (4) Government shall appoint one of the members us Chairman on such terms and conditions as Government may determine.
 - (5) The Chairman shall be an eminent person from the private sector in the field of agriculture, agro-based industry, industry or a profession.

- (6) The tera of office of the Chairman shall be five years and that of the members shall be three years
- (7) Government may at any time remove the Chairman for reasons to be recorded in writing. Const. of the Barbara
- (8) 'Government may on the recommendations of the Chairman at any time remove any, member other than a co-opted member.
- (9) Secretary to the Government of the Zakat and Ushr Department shall also act as Secretary to the Council.
- (10) The Council may at any time remove a co-opted member.

Functions of the Council.

- (i) es Slick and administer Vocational Training Institutes;
- (ii) perform such other functions in relation to such Institutes as may be prescribed, . . .
- The Chairman shall be the Chief Executive of the Council and Powers shall be responsible for the day to day administration and affairs functions of the of the Council

and Chairman.

7. The Council may establish such Boards as may be necessary Constitution of for the efficient performance of its functions and assign to such the Boards. Boards such functions as it may deem necessary.

8. (1) The Council may delegate any of its powers, duties or functions to the Chairman or to any officer of the Council, the Board or the Principal of an Institute.

Delagation of powers.

- (2) The Chairman may delegate any of his powers, other than the powers delegated to him, to any of the officers of the Council or to the Principal of an Institute.
- 9. (1) There shall be a Fund to be known as the Sindh Vocational Training Council Fund which shall vest in the Council and to which shall be credited all moneys received by the Council.

Council Fund.

- (2) The Fund shall be kept in such custody and shall be utilized and regulated in such manner as may be prescribed.
- (3) Government shall provide funds to the Council for its Secretariat and other necessary and incidental expenses.
- 10. The budget of the Council shall be approved and its accounts shall be maintained and audited in such manner as may be prescribed.

Budget audit nd accounts.

11. The Council may employ such officers, advisors, consultants and employees in its service as may be necessary for the efficient performance of its functions in such manner and on such terms and conditions as may be prescribed by regulations.

Employees of the Council.

12. No act, proceedings, resolution or any decision of the Council shall be invalid by reason of any vecancy in the Council

14. Government may make rules for carrying out the purposes of this Act.

Power to make regulations.

15. Subject to this Ordinance and rules the Council may make regulations for carrying out the purposes of this Act.

Ramoval difficulties. 16. If any difficulty arises in giving effect to any provision of this Ordinance, Government may make such order as may be necessary for removing the difficulty.

Repeal

The Sindh Vocational Training Council Ordinance, 2006 is hereby repealed.
