Fresh registration.

execution of this Act; and whenever any change shall take place in the burthen of such vessel employed as aforesaid: fishing-vessel or harbour-craft, or in the name or names of the owner or owners thereof, such registry shall be made again:

Provided, however, that it shall not be lawful to give any name to such vessel employed as aforesaid, fishing-vessel or harbourcraft, other than that by which she was first registered.

Owners to apply for registry.

The owner or owners of every such vessel employed as aforesaid, fishing-vessel and harbour-craft shall apply to the person authorized to make such registry in respect of the same, in order to have such registry as aforesaid made, or in order to have such registry made again as aforesaid.

Information of registry at subordinate port.

And whenever such vessel employed as aforesaid, fishingvessel or harbour-craft is registered at '[a place other than Karachi], information thereof, and of the number there assigned to her, shall immediately be given by the registering officer to '[the Principal Officer].

Officers to perform duty of marking iand branding.

The owner or owners of every such vessel employed as aforesaid fishing-vessel and harbour-craft shall apply for and obtain a certificate of registry from the person, authorised to make such registry as aforesaid, and such certificate shall be in the form specified in the Schedule appended to this Act; and in the case of any certificate being lost or destroyed; a renewed certificate may be obtained in the same manner and on payment of the feeshereinafter mentioned.
