## SIND ACT No. XX OF 1943.1

THE SIND ABKARI (AMENDMENT) ACT, 1943.]

[27th May, 1943]

An Act further to amend the 2[Sind] Abkari Act, 1878.

Whereas it is expedient further to amend the 2[Sind] Sind v Abkari Act, 1878, for the purpose hereinafter appearing; It is of 1878. hereby enacted as follows:-

 This Act may be called the <sup>2</sup>[Sind] Abkari (3\* Amendment) Short title. Act, 1943.

The amendments made in '[the Sind Abkari Act, 1878] of 1878. by the 2[Sind] Abkari (3\* Amendment) Act, 1941, and by this and VI Act shall have effect in respect of all intoxicants as defined in 4[the 1941 and of 1941. Sind Abkari Act, 1878]; including such intoxicants as are dangerous this Act to drugs. [Servent of the State]

Amendments Sind VI of have effect in respect of dangerous

civil or criminal, shall lie in any court of law against the Provincial Government, any officer of the Crown or any authority or persons acting) under the orders of the Provincial Government or of any [such officer] for or in respect of any act, matter or thing in good faith ordered or done or purporting to have been ordered or done under the provisions of the 2[Sind] Abkari (3\* Amendment) Sind VI Act, 1941, before the commencement of this Act, on the ground that of 1941. such act, matter or thing was in excess of the powers conferred by the law as then in force, if the same could lawfully be ordered or done under that Act after the commencement of this Act.
