NO.PAS/Legis-B-14/2010 - The Sindh High Density Development Board Bill, 2010 having been passed by the Provincial Assembly of Sindh on 31st May, 2010 and assented to by the Governor of Sindh on 20th June, 2010 is hereby published as an Act of the Legislature of Sindh.

THE SINDH HIGH DENSITY DEVELOPMENT BOARD ACT, 2010

SINDH ACT NO: X OF 2010

AN

to provide for creation of High

Density Development Board to ensure coordinated and integrated development of the High Density Zones in the urban centers of the Province.

Preamble.

WHEREAS it is expedient to provide for creation of High Density Development Board to ensure coordinated and integrated development of high density zones in the urban centers of the Province and to provide for matters connected therewith and ancillary thereto;

It is hereby enacted as follows:-

Short title, commencement and extent.

- (1) This Act may be called the Sindh 1. High Density Development, Board Act, 2010.
 - (2) It shall extend to the whole of Province of Sindh.
 - (3) It shall come into force at once.

Definitions.

- In this Act, unless there is 2. anything repugnant in the subject or. context-
 - "Board" means the High (i) Density Development Board constituted for cities of the Province under this Act;
 - (ii) "Building Control Department" means a Building Control

Department or an office to be established under the Sind Building Control Ordinance, 1979 to process the applications and approve the plans of the schemes and projects in pursuance of the guidelines of the Board established under section 3;

- (iii)"Government" means the Government of Sindh;
- (iv)"High Density Zones" means an area designated by a High Density Development Board under this Act for construction of high rise buildings in the urban centres of the Province;
 - (v)"Member" means a Member of the Board appointed under section 3;
 - (vi)"prescribed" means prescribed by rules; and
- (vii)"rules" means the rules made under this Act.
- 3. Government shall constitute a Constitution of Board for the cities of the Province Board. under this Act. The Board shall consist of the following:-

- (i) Governor of **Chairman** Sindh
- (ii) Chief Minister, Co-Sindh Chairman
- (iii) Minster, Local Member
 Government
 and Housing
 Town Planning
 Department
- (iv) Chief Secretary, **Member** Sindh
- (v) Secretary, Local **Member**Government,
 Housing
 - (vi) Nazim of the **Member** respective
 District
 - (vii) Chief Controller Member/
 of Buildings or Head of Building
 Control of the
 respective
 District as the
 case may be

(viii) Executive District Officer, MPGO or Head of Master Plan of the respective. District as the case may be.

Member

- 4. The Board shall identify and Identification earmark the high-density zones in the of high density urban centres of the cities of the zones. Province, in consultation with the respective utility agencies, keeping in view the general principles of Master Plan.
- 5. Government may make rules for carrying out the purposes of this Act.

Power to make rules.
