**NO.PAS/Legis-B-17/2013** The Hyderabad Development Authority (Revival and Amending) Bill, 2013 having been passed by the Provincial Assembly of Sindh on 19<sup>th</sup> September, 2013 and assented to by the Governor of Sindh on 27<sup>th</sup> November, 2013 is hereby published as an Act of the Legislature of Sindh.

THE HYDERABAD DEVELOPMENT AUTHORITY (REVIVAL AND AMENDING) ACT, 2013.

SINDH ACT NO. LVII OF 2013.

AN

to revive and amend the law relating to the Hyderabad Development Authority.

WHEREAS in order to give impetus and Preamble. encourage the housing industry and provide shelter to the people of the Province, it is expedient to revive and amend the Hyderabad Development Authority Act, 1976, in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and commencement.

Revival of Sindh Act No.XIII of 1976.

Amendment of section 2 of Sindh Act No.XIII of 1976.

Amendment of section 4 of Sindh Act No.XIII of 1976.

- 1.(1) This Act may be called the Hyderabad Development Authority (Revival and, Amending), Act, 2013.
  - (2) It shall come into force at once.
- The Hyderabad Development Authority Act, 1976, shall stand revived on and from 1st Day of July, 2002, as if it had never been repealed and on revival shall hereinafter be referred to as the said Act.
- In the said Act, in section 2, after clause (e), the following new clause shall be inserted:-
  - "consolidation of land" "(ee) adjustment of plots in a scheme by way of exchange or otherwise for the purpose of the scheme;".
- In section 4, for sub section (1), the following shall be substituted:-
  - "(1)Constitution of the Authority.- The Authority shall consist of:
    - for Local Chairman (a) Minister Government, Public Health Rural Engineering, Development and Housing Town Planning, Sindh
  - (b) One Local Member of Member theProvincial Assembly to be nominated by Government
  - (c) Secretary, Local Government, Public Health Engineering, Rural Development and Housing Town Planning Department
  - (d) Commissioner, Hyderabad
  - (e) Chief Engineer, Public Member Health Engineering, Hyderabad
  - (f) Director General Hyderabad Member/ Development Authority
  - Persons to nominated by Government (one Technocrat and one from Civil Society)

In section 9, in sub section (1), after clause (iii), Amendment of the following new clause shall be inserted:-

section 9 of Sindh Act

"(iii-a) consolidate any land in such manner as No.XIII of 1976. may be prescribed by the rules;".

All orders made, proceedings taken, Saving. appointments, made, acts done by any authority, or by any person, which were made, taken or done, or purported to have been made, taken or done between the first day of July, two thousand two, and the date on which this Act comes into force (both days inclusive), shall, notwithstanding any judgment of any court, be deemed to be and always to have been validiy made, taken or done under the Hyderabad Development Authority Act, 1976 and shall not be called in question in any court or forum on any ground whatsoever.
