THE SINDH UNIVERSITIES AND INSTITUTES LAWS (AMENDMENT) BILL, 2014.

SINDH BILL NO. 37 OF 2014.

BILL

to amend the certain laws relating to the Universities and Institutes in force in the Province of Sindh.

WHEREAS it is expedient to amend the certain laws relating to Preamble. the Universities and Institutes in force in the Province of Sindh, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Universities and Institutes Short title and Laws (Amendment) Act, 2014.

commencement.

- (2) It shall come into force at once.
- In the Sindh University Ordinance, 1972, in section 13, for sub- Amendment in Sindh section (1), the following shall be substituted:-

Ordinance No.XVI of 1972.

- "(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".
- In the University of Karachi Act, 1972, in section 13, for Amendment in Sindh sub-section (1), the following shall be substituted:-

Act No.XXV of 1972.

- "(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".
- In the N.E.D. University Act, 1977, in section 27, for Amendment in Sindh sub-section (1), the following shall be substituted:-

Act No.III of 1977.

- "(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.
- In the Mehran University Act, 1977, in section 27, for Amendment in Sindh sub-section (1), the following shall be substituted:-

Act No.IV of 1977.

"(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of

Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".

- "(1-A) Notwithstanding anything contained in this Act or any other law, for the time being in force, any person who had ceased to hold office as the Vice Chancellor in consequence of enactment of the Sindh Universities Laws (Amendment) Act, 2013 (Sindh Act No.XLIII of 2013), Government may, keeping in view of his performance of such person, direct him to continue for a period of not more than two years as the Vice Chancellor.".
- In the Sindh Agriculture University Act, 1977, in section 27, for Amendment in Sindh sub-section (1), the following shall be substituted:-

Act No.V of 1977.

- "(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".
- In the Shah Abdul Latif University Act, 1986, in section 13, for Amendment in Sindh sub-section (1), the following shall be substituted:-

Act No.XI of 1986.

- "(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".
- In the Institute of Business Administration Act, 1994, in Amendment in Sindh section 9, for sub-section (1), the following shall be substituted:-

Act No.XX of 1994.

- "(1) There shall be a Director of the Institute who shall be an eminent academic or a distinguished administrator and shall be appointed by the Patron on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".
- In the Quaid-e-Awam University of Engineering and Science Amendment in Sindh Technology Nawabshah Act, 1996, in section 27, for sub-section (1), Act No.XIX of 1996. the following shall be substituted:-

"(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".

In the Liaquat University of Medical and Health Sciences Amendment in Sindh Ordinance 2000 in section 14 for sub-section (1), the following shall Sindh Ordinance be substituted:-

- "(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine.".
- In the Dow University of Health Sciences Act, 2004, in Amendment in Sindh 11. section 14, for sub-section (1), the following shall be substituted:-

Act No.X of 2004.

- "(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine.
- (1-A). Notwithstanding anything contained in this Act or any other law, for the time being in force, any person who had ceased to hold office as the Vice Chancellor in consequence of enactment of the Sindh Universities Laws (Amendment) Act, 2013 (Sindh Act No.XLIII of 2013), Government may, keeping in view of his performance of such person, direct him to continue for a period of not more than two years as the Vice Chancellor.".
- In the Sukkur Institute of Business Administration Act, 2006, in section 12, for sub-section (1), the following shall be substituted:-

Amendment in Sindh Act No.XVIII of 2006.

- "(1) There shall be a Director of the Institute who shall be an eminent academic or a distinguished administrator and shall be appointed by the Patron on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".
- In the Shaheed Mohtarma Benazir Bhutto Medical University Larkana Act, 2008, in section 10, for sub-section (1), the following shall be substituted:-

Amendment in Sindh Sindh Act No.VI of 2008.

- "(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine.
- In the Peoples University of Medical and Health Sciences for Amendment in Sindh Women, Shaheed Benazirabad Act, 2009, in section 13, for sub-section Act No.XX of 2010. (1), the following shall be substituted:-

"(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be

extended for one more term, on such terms and conditions as Government may determine.".

In the Benazir Bhutto Shaheed University at Lyari, Karachi Act, Amendment in Sindh 2009, in section 12, for sub-section (1), the following shall be Act No.I of 2010. substituted:-

- "(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".
- In the Shaheed Benazir Bhutto University, Shaheed Amendment in Sindh Benazirabad Act, 2009, in section 12, for sub-section (1), the following Act No.XIX of 2010. shall be substituted:-

- "(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".
- In the Sindh Madressatul Islam University Act, 2012, in Amendment in Sindh section 12, for sub-section (1), the following shall be substituted:-

Act No.VI of 2012.

- "(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".
- In the Shaheed Benazir Bhutto University of Veterinary and Amendment in Sindh Animal Sciences Sakrand Act, 2012, in section 12, for sub-section (1), Act No.XV of 2012. the following shall be substituted:-

- "(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".
- In the Shaheed Zulfiqar Ali Bhutto University of Law, Karachi Amendment in Sindh Act, 2012, in section 12, for sub-section (1), the following shall be Act No.XIII of 2013. substituted:-

"(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be

extended for one more term on such terms and conditions as Government may determine.".

In the Jinnah Sindh Medical University Act, 2013, in section Amendment in Sindh 13, for sub-section (1), the following shall be substituted:-

Act No.XXIII of 2013.

"(1) There shall be a Vice Chancellor of the University who shall be a Professor of medical profession and eminent and academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.".

STATEMENT OF OBJECTS AND REASONS

In order to determine the terms and conditions of the Chancellor of the University and Director of the Institute in public sector by Government, it is expedient to make suitable amendments in various laws relating to the Universities and Institutes in force in the Province of Sindh.

The Bill seeks to achieve the above object.
