**NO.PAS/Legis-B-37/2014-** The Sindh Universities and Institutes Laws (Amendment) Bill, 2014 having been passed by the Provincial Assembly of Sindh on 17<sup>th</sup> November, 2014 and assented to by the Governor of Sindh on 1<sup>st</sup> January, 2015 is hereby published as an Act of the Legislature of Sindh.

**THE SINDH UNIVERSITIES AND INSTITUTES LAWS  
(AMENDMENT) ACT, 2014.**

**SINDH ACT NO. V OF 2015.**

**AN  
ACT**

to amend the certain laws relating to the Universities and Institutes in force in the Province of Sindh.

**WHEREAS** it is expedient to amend the certain laws relating to the Universities and Institutes in force in the Province of Sindh, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Universities and Institutes Laws (Amendment) Act, 2014. **Short title and commencement.**
- (2) It shall come into force at once.



**Amendment in Sindh Act No.XXIV of 1972.**

2. In the University of Sindh Act, 1972, in section 13, for sub-section (1), the following shall be substituted:-

"(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine."

**Amendment in Sindh Act No.XXV of 1972.**

3. In the University of Karachi Act,1972, in section 13, for sub-section (1), the following shall be substituted:-

"(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine."

**Amendment in Sindh Act No.III of 1977.**

4. In the N.E.D. University Act,1977, in section 27, for sub-section (1), the following shall be substituted:-

"(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine."

**Amendment in Sindh Act No.IV of 1977.**

5. In the Mehran University of Engineering and Technology Act,1977, in section 27, for sub-section (1), the following shall be substituted:-

"(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine."

"(1-A) Notwithstanding anything contained in this Act or any other law, for the time being in force, any person who had ceased to hold office as the Vice Chancellor in consequence of enactment of the Sindh Universities Laws (Amendment) Act, 2013 (Sindh Act No.XLIII of 2013), Government may, keeping in view of his performance of such person, direct him to continue for a period of not more than two years as the Vice Chancellor."

**Amendment in Sindh Act No.V of 1977.**

6. In the Sindh Agriculture University Act,1977, in section 27, for sub-section (1), the following shall be substituted:-

"(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine."



7. In the Shah Abdul Latif University Act, 1986, in section 13, for sub-section (1), the following shall be substituted:- **Amendment in Sindh Act No.XI of 1986.**

"(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine."

8. In the Institute of Business Administration Act, 1994, in section 9, for sub-section (1), the following shall be substituted:- **Amendment in Sindh Act No.XX of 1994.**

"(1) There shall be a Director of the Institute who shall be an eminent academic or a distinguished administrator and shall be appointed by the Patron on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine."

9. In the Quaid-e-Awam University of Engineering, Science and Technology, Nawabshah Act, 1996, in section 27, for sub-section (1), the following shall be substituted:- **Amendment in Sindh Act No.XIX of 1996.**

"(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine."

10. In the Liaquat University of Medical and Health Sciences Ordinance, 2000, in section 14, for sub-section (1), the following shall be substituted:- **Amendment in Sindh Ordinance No.VIII of 2001.**

"(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine."

11. In the Dow University of Health Sciences Act, 2004, in section 12, for sub-section (1), the following shall be substituted:- **Amendment in Sindh Act No.X of 2004.**

"(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine."



(1-A). Notwithstanding anything contained in this Act or any other law, for the time being in force, any person who had ceased to hold office as the Vice Chancellor in consequence of enactment of the Sindh Universities Laws (Amendment) Act, 2013 (Sindh Act No.XLIII of 2013), Government may, keeping in view of his performance of such person, direct him to continue for a period of not more than two years as the Vice Chancellor.”.

12. In the Sukkur Institute of Business Administration Act, 2006, in section 12, for sub-section (1), the following shall be substituted:- **Amendment in Sindh Act No.XVII of 2006.**

“(1) There shall be a Director of the Institute who shall be an eminent academic or a distinguished administrator and shall be appointed by the Patron on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

13. In the Shaheed Mohtarma Benazir Bhutto Medical University Larkana Act, 2008, in section 10, for sub-section (1), the following shall be substituted:- **Amendment in Sindh Sindh Act No.VI of 2008.**

“(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine.

14. In the Peoples University of Medical and Health Sciences for Women, Shaheed Benazirabad Act, 2009, in section 13, for sub-section (1), the following shall be substituted:- **Amendment in Sindh Act No.XX of 2010.**

“(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine.”.

15. In the Benazir Bhutto Shaheed University at Lyari, Karachi Act, 2009, in section 12, for sub-section (1), the following shall be substituted:- **Amendment in Sindh Act No.I of 2010.**

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

16. In the Shaheed Benazir Bhutto University, Shaheed Benazirabad Act, 2009, in section 12, for sub-section (1), the following shall be substituted:- **Amendment in Sindh Act No.XIX of 2010.**



“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

17. In the Sindh Madressatul Islam University Act, 2012, in section 13, for sub-section (1), the following shall be substituted:-

**Amendment in Sindh Act No.VI of 2012.**

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

18. In the Shaheed Benazir Bhutto University of Veterinary and Animal Sciences Sakrand Act, 2012, in section 12, for sub-section (1), the following shall be substituted:-

**Amendment in Sindh Act No.XV of 2012.**

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

19. In the Shaheed Zulfiqar Ali Bhutto University of Law, Karachi Act, 2012, in section 12, for sub-section (1), the following shall be substituted:-

**Amendment in Sindh Act No.XIII of 2013.**

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

20. In the Jinnah Sindh Medical University Act, 2013, in section 13, for sub-section (1), the following shall be substituted:-

**Amendment in Sindh Act No.XXIII of 2013.**



"(1) There shall be a Vice Chancellor of the University who shall be a Professor of medical profession and eminent and academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine."
