ORDINANCE

to amend the West Pakistan (Board of Intermediate and Secondary Education, Karachi) Ordinance, 1962.

Preamble.

WHEREAS it is expedient to amend the West Pakistan (Board of Intermediate and Secondary Education, Karachi) Ordinance, 1962, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Martial Law Proclamation of 25th March, 1969, read with the Provisional Constitution Order, and in exercise of all powers enabling him in that behalf, the Governor of Sind is pleased to make and promulgate the following Ordinance.—

Short tittle and commencement.

- 1. (1) This Ordinance may be called the West Pakistan (Board of Intermediate and Secondary Education, Karachi) (Sind Amendment) Ordinance, 1971.
 - (2) It shall come into force at once.

- 5. In section 12 of the principal Ordinance, in sub-section (5)-
 - (a) between the word and comma "Ordinance," and the words "the Controlling Authority", the comma and the words "or is in any way against the public interest," shall be inserted;
 - (b) for the words and comma "by order in writing, annul such proceeding", the words "may review such proceeding and on such review require the Board to take such action as may be specified, and the Board shall take action accordingly" shall be substituted; and
 - (c) the proviso shall be omitted.
- 6. In section 14 of the principal Ordinance—
 - (a) in sub-section (1), for the words "the Controlling Authority", twice occurring, the word "Government" shall be substituted;
 - (b) in sub-section (2), the full stop at the end shall be replaced by a colon; and
 - (c) in sub-section (3), for the words "the Controlling Authority", the word "Government" shall be substituted.
