ORDINANCE

to amend the West Pakistan Motor Vehicles Ordinance, 1965, in its application to the Province of Sind.

Preamble.

WHEREAS it is expedient to amed the West Pakistan Motor Vehicles Ordinance, 1965, in its application to the Province of Sind, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Martial Law Proclamation of 25th March, 1969, read with the Provisional Constitution Order, and in exercise of all powers enabling him in that benalf, the Governor of Sind and Martial Law Administrator, Zone 'D', is pleased to make and promulgate the following Ordinance:

Short title. extent and commencement.

1. (1) This Ordinance may be called the West Pakistan Motor Vehicles (Sind Amendment) Ordinance, 1971.

(2) It shall extend to the whole of the Province of Sind.
