## THE WEST PAKISTAN BOARD OF REVENUE (SIND AMENDMENT) ORDINANCE, 1970

[30<sup>th</sup> July, 1970]

An Ordinance to amend the West Pakistan Board of Revenue Act, 1957, in its application to the Province of Sind.

**WHEREAS** it is expedient to amend the West Pakistan Board **Preamble**. of Revenue Act, 1957, in its application to the Province of Sind, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Martial Law Proclamation of 25th March, 1969, read with the Provisional Constitution Order, and in exercise of all powers enabling him in that behalf, the Governor of Sind is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the West Pakistan Board of Short title and Revenue (Sind Amendment) Ordinance, 1970.

- (2) It shall be deemed to have come into force on and from 1st July, 1970.

- 7. In section 6 of the said Act, after sub-section (3), the following Explanation shall be added, namely:
  "Explanation.- In this section and in section 7, the expression "Member" or "Members" shall include an Additional Member or Members."
- 8. Sections 10 and 11 of the said Act shall be repealed. Repeal of sections 10 and 11 of W.P. Act XI 1957.
