to amend the Jacobabad Institute of Medical Sciences Act, 2013.

WHEREAS it is expedient to amend the Jacobabad Institute of Medical Sciences Act, 2013, in the matter hereinafter appearing

It is hereby enacted as follows:-



1. (1) This Act may be called the **Jacobabad Institute of Medical Sciences (Amendment) Act, 2017.** Short title and commencement
- (2) It shall come into force at once.
2. In the said Act, in section 8, for sub-section (1), the following shall be substituted:-
- (1) The general direction and administration of the Institute and its affairs shall vest in the Board consisting of the following:-
- (i) Minister Health, or if there is no Minister Health, Member of Cabinet nominated by the Chief Minister. Chairman
- (ii) Member of Provincial Assembly of the Constituency where the Institute is located. Member
- (iii) Secretary Health. Member
- (iv) Commissioner of the District or in his absence the Deputy Commissioner Jacobabad. Member
- (v) A Professional having substantial contribution to the field of Medical Sciences recognized nationally and internationally (nominated by the Chief Minister). Member
- (vi) Officer commanding or his representative of Pakistan Air Force, Shaheed Base Jacobabad, not below the rank of group Captain. Member
- (vii) One reputed citizen from the adjacent area of Jacobabad (nominated by the Chief Minister). Member
- (viii) Chairman, District Council Jacobabad. Member
- (ix) One representative of USAID. Member
- (x) One nominee of Academic Council. Member
- (xi) Director of the Institute. Member/Secretary

3. There shall be a separate non-lapsable fund for the Institute known as the "Jacobabad Institute of Medical Sciences Fund". Amendment of Section 16(1) of Sindh Act No. XIX of 2013.
