NO.PAS/LEGIS-B-21/2018-The Sindh (Regularization of Contract Employees of Khairpur Medical College, Khairpur) Bill, 2018 having been passed by the Provincial Assembly of Sindh on 24<sup>th</sup> May, 2018 and assented to by the Governor of Sindh on 05<sup>th</sup> June, 2018 is hereby published as an Act of the Legislature of Sindh.

to provide for regularization of the services of  
employees appointed on contract basis in the Khairpur

WHEREAS it is expedient to provide for regularization Preamble.  
of the services of employees appointed on contract basis in  
the Khairpur Medical College, Khairpur, and to provide for  
matters connected therewith or ancillary thereto;

It is hereby enacted as follows:-



1. (1) This Act may be called the Sindh (Regularization of Contract Employees of Khairpur Medical College, Khairpur) Act, 2018. Short title and commencement.

(2) It shall come into force at once.

2. (1) In this Act, unless context otherwise requires - Definitions.

- (a) "Act" means the Sindh Civil Servants Act, 1973;
- (b) "appointment" means the appointment of a duly qualified employee made on contract basis;
- (c) "civil servant" shall have the same meaning as assigned to it in the Act;
- (d) "employee" means a person appointed on contract basis in the Khairpur Medical College, Khairpur;
- (e) "Government" means the Government of Sindh;
- (f) "post" means a post held by an employee and sanctioned by Government connected with the affairs of the Province.

3. (1) Notwithstanding anything contained in the Act or rules made thereunder or any decree, order or judgment of a court, but subject to other provisions of this Act, an employee appointed on contract basis and is holding such appointment, immediately before the commencement of

this Act, shall be deemed to have been validly appointed to that post as a civil servant on regular basis **including Principal of the College**, with effect from the date of appointment.

(2) The orders of regularization under sub-section (1) shall not be made unless antecedents of such employee with regard to his academic qualifications, experience, age and place of domicile are scrutinized and cleared by the Special Committee.

(3) The Special Committee under sub-section (2) shall be headed by the Secretary of the Health Department and three other members, **one** from the Health Department to be nominated by the Secretary Health Department and **three** from the Services Wing of the Services and General Administration Department **within six weeks**.
