PROVINCIAL ASSEMBLY OF SINDH NOTIFICATION KARACHI, THE 11TH MAY, 2018

NO.PAS/LEGIS-B-09/2018-The Provincial Assembly of Sindh in its sitting held on 09th March, 2018 passed the Sindh Universities and Institutes Laws (Amendment) Bill, 2018 and was sent to Honourable Governor for accord his assent as required under clause (2)(a) of Article 116 but he, instead of accord assent to the Bill, returned the same with message in exercise of powers vested upon him under clause 2(b) of Article 116.

The Provincial Assembly of Sindh in its sitting held on 13th April, 2018 reconsidered the Bill and passed it again v hich was accordingly sent to the Governor for accord his assent. The leriod of ten days has been elapsed and the subject bill shall be deem d to have been assented by the Governor in view of clause (3) of Article 116 of the Constitution and is hereby published as an Act of the Legislature of Sindh.

SINDH ACT NO. XV OF 2018

to amend certain laws felating to the Universities and Institutes, in force, in the Province of Sindh.

WHEREAS It is experient to maintain uniformity in the Preamble organization, management and control of public sector Universities and degree awarding institutes in the Province of Sindh and to amend certain laws relating thereto, in the manner hereinafter appearing,

It is hereby enacted as follows:-

- (1) This Act may be called the Sindh Universities and Institutes
 Short title and Commencement.
 Act, 2018.

 - "(1-A) The Professional and academic qualifications, experience and age for the post of Vice-Chancellor shall be as such as may be prescribed.";
- (iii) in sub-sections (4) and (5), for the word "Chancellor", the words "Chief Minister" shall

be substituted;

- (iv) sub-section (6) shall be omitted;
- (v) for sub-section (7), the following shall be substituted:-
 - "(7) The Chief Minister shall, in case of allegation of gross misconduct, inefficiency, corruption, violation of budgetary provisions, moral turpitude, maladministration and mismanagement, remove the Vice-Chancellor, on the basis of substantiated findings of an enquiry committee after giving him an opportunity of show cause against such removal.";
- (vii) sub-section (8), shall be omitted; (vii) in sub-section (9), for the word "Chancellor", the words "Chief Minister" shall be substituted;
- (viii) after sub-section (9), the following shall be added.-
 - "(5) The Vice Chancellor may avail leave with the permission of Chief Minister or any other authority duly authorized by the Chief Minister in this behalf.".

11. In section 16 -

- (i) for sub-section (1), the following shall be substituted:-
 - "(1) The Pro-Vice Chancellor shall be from amongst University Professors to be appointed by the Chief Minister, for the main campus or of the additional campus, if any, or for both the campuses jointly or separately, on such terms and conditions and such age and for such period not exceeding four years at a time as may be prescribed.";
- (ii) in sub-section(2) for the word "Chancellor" the words "Chief Minister" shall be substituted;
- (iii) in sub-section (3) after the words "Academic Council", the words "for the matter pertaining to the campus he is appointed" shall be inserted.

. 12. In section 17 -

- (i) in sub-section (1), for the word "Senate", the word "syndicate" shall be substituted and for the word "Government" the words "Selection Board" shall be substituted; and
- (ii) in sub-section (3), in the proviso, for the word "Senate" the word "Syndicate" shall be substituted.
- 13. For section 18, the following shall be substituted:-
 - "18. Treasurer (1) shall be a whole-time officer of the University and shall be appointed by Chief Minister from a panel of three candidates recommended by the Search Committee on such terms and conditions as it may determine. He
 - (a) hold office for a period of three years on the expiry of which he shall be eligible for re-appointment;
 - (b) be Chief Financial Officer of the
 - University:
 (c) manage the property, assets, liabilities; finances, receipts expenditure, funds and the investments of the University:
 - (d) prepare the annual and revised budget estimates of the University and present them to the Finance Committee, the Syndicate and the Senate;
 - (e) ensure that the funds of the University are expended for the purposes for which they are provided;
 - (f) perform such other duties as may be prescribed.
 - (2) The experience as well as the professional and academic qualifications for post of the Treasurer shall be such as may be prescribed.
 - (3) The Treasurer shall be assisted by the Chief Accountant, Bursar and the Resident Auditor.".

14. In section 19 -

(i) In sub-section (1), for the word "Senate on the recommendations of Government", the words "Syndicate on the recommendations of the Selection Board" shall be substituted;

- (ii) in sub-section (4), in the proviso, for the word "Senate", the word "Syndicate" shall be substituted.
- 15. After section 19, the following shall be substituted:
 - "19-A. Resident Auditor, Chief Accountant and Bursar (1) The Resident Auditor shall be whole-time officer of the University and shall be appointed by the Pro-Chancellor who shall be a Cabinet Minister on such terms and conditions as it may determine. He shall be responsible for all matters connected with the auditing of accounts of the University and shall perform such other duties as may be prescribed.
 - (2) The Chief Accountant and Bursar shall be whole-time officers of the University and shall be appointed by the Syndicate on the recommendations of Selection Board on such terms and conditions as it may determine. They shall assist the Director Finance and perform other such duties as may be prescribed.
 - 19-B.The Director Planning & Development. The Director Planning & Development shall be a whole-time officer of the University and shall be appointed by the Syndicate on the recommendations of Selection Board on such terms and conditions as it may determine. He shall be responsible for the planning and development of the University and shall present the development plans and proposals to the Finance and Planning Committee and other relevant authorities of the University.
 - 19-C. The Director (Works and Services). The Director (Works and Services) shall be whole time officer of the University and shall be appointed by the Syndicate on recommendation of the Selection Board on such terms and conditions as it may determine. He shall be responsible for the execution of the development projects, provision of services, procurement and installation of equipment and machinery and other tools and materials and proper maintenance of all works and services of the university.
 - 19-D The Librarian. The Librarian shall be a whole-time officer of the University and shall be

appointed by the Syndicate on the recommendations of Selection Board.

19-E. Other whole-time Officers of the University. All the other remaining officers mentioned in section 8, shall be appointed by such officer or authority as authorized by Government on such terms and conditions as it may determine. They shall perform their duties as may be prescribed."

16. In section 21 -

- sub-section (1), in clause (i), (j) and (k), for the word "Government", the words "Chief Minister" shall be substituted;
- (ii) in sub-section (4), for the word "Chancellor", the word "Chief Minister" shall be substituted;
- (iii) in sub-section (8), the following shall be substituted:-

"The meetings of the Senate shall be presided over by the Chairperson or in his absence by the Pro-Chancellor, or in the absence of both, by the Vice Chancellor."

17. In section 22, in sub-section (3) -

- (i) clause (d) shall be omitted:
- (ii) in clause (e), after the word "University", the words "not expressly provided in this Act" shall be inserted;
- (iii) in clause (j), for the words "Chancellor", the words "Chief Minister" shall be substituted;
- (iv) clause (k) shall be omitted

18. In section 23 - .

- (i) for sub-section (1) the following shall be substituted:-
- "(1) The Syndicate shall consist of :-
 - (i) the Vice Chancellor, who shall be its Chairperson;
 - (ii) the Pro-Vice Chancellor, if appointed, to the extent of the matters relevant to the concerned campus;

- (iii) one member of the Provincial Assembly to be nominated by the Speaker of Provincial Assembly;
- (iv) two members of the Senate elected by the Senate;
- (v) a Judge of the High Court nominated by the Chief Justice;
- (vi) the Secretary to the Government of Sindh of Relevant Department or his nominee not below the level of Additional Secretary;
- (vii) One Nominee of Higher Education Commission of Pakistan;
- (viii) the Secretary to the Government of Sindh, Universities and Boards Department or his nominee not below the level of Additional Secretary:
- (ix) the Chairperson Sindh Higher Education Commission or his nominee not below the rank of whole-time member of the Commission:
- Commission;
 (x) one Dean of the University to be nominated by the Vice-Chancellor;
- (xi) one Professor to be elected by the Professors of the University from amongst themselves;
- (xii) one Associate Professor to be elected by the Associate Professors of the University from amongst themselves;
 (xiii) one Assistant Professor to be elected by
- (xiii) one Assistant Professor to be elected by the Assistant Professors of the University from amongst themselves;
- (xiv) one Lecturer with minimum Service of two years to be elected by the Lecturers of the University from amongst themselves;
- (xv) three persons of eminence to be nominated by the Chief Minister;
- (xvi) one Principal of an affiliated Colleges, if any, and the Principals of the constituent coileges to the extent of matters relevant to the concerned constituent college to be nominated by the Vice-Chancellor;
- (xvii) one Alim and one woman not serving in any educational institute to be nominated by the Chief Minister; and
- (xviji) one University officer of administration side to be elected from amongst all administrative officers.";
- (ii) in sub-section (3), for the word "three University Teachers", the word "four University Teachers and University Officers of Administration" shall be substituted.

19. In section 24, in sub-section (2), after clause (t) the following shall be inserted;-

"(t-i) to appoint on the recommendation of the Selection Board, the University Teachers and employees to posts in Basic Scale 17 and above;"

- 20. In section 25, in sub-section (2), for the word "Senate", wherever appearing, the word "Syndicate" shall be substituted.
- 21. In section 29, in sub-section (2), for the word "Chancellor", wherever appearing, the word "Chief Minister" shall be substituted.
 - 5. In section 30 -
 - (i) in sub-section (2), after the word "Senate" the words "with prior approval of Syndicate" shall be inserted;
 - (ii) sub-section (4) shall be omitted.
- 22. In section 44, after the words "the Act shall", the words "be reconstituted by the Chairperson in accordance with provisions of Sindh Universities Laws and Institutes (Amendment) Act, 2018" shall be inserted
- 23. In section 46, for the word "Chancellor", wherever appearing the words "Chief Minister" shall be substituted;
- 24. In the Schedule, in clause 1, after sub-clause (7), the following new clause shall be inserted:-
 - (8) Selection Board. (1) The Selection Board shall consist of -
 - (i) the Vice Chancellor (Chairperson);
 - (ii) the Secretary Universities and Boards Department;
 - (iii) Chairperson or a member of the Sindh Public Service Commission to be nominated by its Chairperson;
 - (iv) the Dean of the Faculty concerned; (v) the Chairman of the Teach
 - (v) the Chairman of the Teaching Department concerned;
 - (vi) one member of the Syndicate to be appointed by it and two other persons of eminence, to be appointed by the Senate, provided that none of the three are employees of the University;

- (2) The members mentioned in sub-clause (vi) of clause (1) shall hold office for two years.
- (3) (a) Four members shall form the quorum for the selection of a Professor or an Associate Professor and three members for the selection of other Teachers.
 - (b) In case of Officers other than teachers, the Selection Board shall consist only of members at sub-clauses (i), (ii), (iii) and (vi) of clause (1).
- (4) No member who is a candidate for the post to which appointment is to be made shall take part in the proceedings of the Board.
- (5) In selecting candidates for the posts of Professors and Associate Professors, the Selection Board shall co-opt or consult three experts in the subject concerned and in selecting candidates for other teaching posts, two experts in the subject concerned, to be nominated by the Vice-Chancellor from a standing list of experts for each subject approved by the Syndicate on the recommendation of the Selection Board and revised from time to time but not less than once in six months."
