to amend the Sind Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975

WHEREAS it is expedient to amend the Sind Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975, in the manner hereinafter appearing;

1. (1) This Act may be called the Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Act, 1989.

(2) It shall come into force at once.

2. In the Sind Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975, hereinafter referred to as the said Act, after section 7, the following new section shall be inserted:

"7-A(1) The Speaker may in his discretion make grants to the extent of fifty thousand rupees in a year: Discretionary Grants

(2) The accounts of the grants shall be audited annually by the Accountant General, Sindh or his nominee.".
