NO.PAS/LEGIS-B-01/2020-The Provincial Motor Vehicles (Amendment) Bill, 2020 having been passed by the Provincial Assembly of Sindh on 08th January, 2020 and assented to by the Governor of Sindh on 17th January, 2020 is hereby published as an Act of the Legislature of Sindh.

THE PROVINCIAL MOTOR VEHICLES (AMENDMENT) ACT, 2020 SINDH ACT NO. II OF 2020

to amend the Provincial Motor Vehicles Ordinance, 1965.

WHEREAS it is expedient to amend the Provincial Preamble. Motor Vehicles Ordinance, 1965, in the manner hereinafter appearing;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Provincial Motor Vehicles Short title and (Amendment) Act, 2020.
 - commencement.

(2) It shall come into force at once.

- 2. In the Provincial Motor Vehicles Ordinance, 1965, hereinafter referred to as the said Ordinance, in section 2, for clause (4), the following shall be substituted:-
 - "(4) "certificate of registration" means and of 1965. includes the Security Featured Motor Vehicle Registration (MVR) Smart Card issued by the competent authority to effect that a motor vehicle has been registered in accordance with the provisions of Chapter-III;".

Amendment of section 2 of the West Pakistan **Ordinance No.XIX**

In the said Ordinance, in the First Schedule, in Amendment of Form-G, for the word and figures "(see sections 2(2) and 41(2), the word and figures "(see sections 2(2), 2(4) and 41(2)" shall be substituted.
