**NO.PAS/Legis-B-25/2011-** The Sindh (Repeal of the Sindh Local Government Ordinance, 2001 and Revival of the Sindh Local Government Ordinance, 1979) Bill, 2011 having been passed by the Provincial Assembly of Sindh on 13<sup>th</sup> July, 2011 and assented to by the Governor of Sindh on 14<sup>th</sup> July, 2011 is hereby published as an Act of the Legislature of Sindh.

to repeal the Sindh Local Government Ordinance, 2001 (Ordinance No.XXVII of 2001) and revive the Sindh Local Government Ordinance,1979 (Ordinance No.XII of 1979).



**Preamble.**

**WHEREAS** it is expedient to repeal the Sindh Local Government Ordinance, 2001 (Ordinance No.XXVII of 2001) and revive the Sindh Local Government Ordinance,1979 (Ordinance No.XII of 1979), in the manner hereinafter appearing;

It is hereby enacted as follows:-

**Short title and commencement.**

1.(1) This Act may be called the Sindh (Repeal of the Sindh Local Government Ordinance,2001 and Revival of the Sindh Local Government Ordinance,1979) Act,2011.

(2) It shall come into force at once.

**Revival of Sindh Ordinance No.XII of 1979.**

2. The Sindh Local Government Ordinance,1979 (Ordinance No.XII of 1979), in its original position as stood on 05.08.2001 is revived with immediate effect as if it had never been repealed.

**Repeal of Sindh Ordinance No.XXVII of 2001.**

3. The Sindh Local Government Ordinance, 2001 (Ordinance No.XXVII of 2001) is hereby repealed with immediate effect.

**Saving.**

4. Notwithstanding the repeal of the Sindh Local Government Ordinance, 2001 (Ordinance No.XXVII of 2001), all orders made (including rules, bye-laws, regulations and notifications and other legal instruments), proceedings taken, appointments made, acts done by any authority or any person, which were made, taken or done, or purported to have been made, taken or done thereunder, between the sixth day of August,2001 and the date on which this Act comes into force (both days inclusive), shall continue to remain in force, until altered, repealed or amended by the Chief Minister or any authority or officer, authorized by him.

5. If any difficulty arises in giving effect to the provisions of this Act, the Chief Minister may, by notification in the official gazette, make such provisions as appear to be necessary or expedient for removing the difficulty. **Removal of difficulty.**

6. The Sindh (Repeal of the Sindh Local Government Ordinance, 2001 and Revival of the Sindh Local Government Ordinance, 1979) Ordinance, 2011 is hereby repealed. **Repeal.**
