NO.PAS/LEGIS-B-17/2021-The Sindh (Repeal of Police Act, 1861 and Revival of Police Order 2002) (Amendment) Bill, 2021 having been passed by the Provincial Assembly of Sindh on 07th June, 2021 and assented to by the Governor of Sindh on 02nd July, 2021 is hereby published as an Act of the Legislature of Sindh.

THE SINDH (REPEAL OF POLICE ACT, 1861 AND REVIVAL OF POLICE ORDER 2002) (AMENDMENT) ACT, 2021

#### SINDH ACT NO. XVIII OF 2021

#### AN ACT

to amend the Sindh (Repeal of Police Act, 1861 and Revival of Police Order 2002) (Amendment) Act, 2019.

WHEREAS it is expedient to amend the Sindh (Repeal of Police Preamble. Act, 1861 and Revival of Police Order 2002) (Amendment) Act, 2019, in the manner hereinafter appearing;

It is hereby enacted as follows :-

1. (1) This Act may be called the Sindh (Repeal of Police Act, 1861 and Short title and Revival of Police Order 2002) (Amendment) Act, 2021. commencement.

(2) It shall come into force at once.

2. In the Sindh (Repeal of Police Act, 1861 and Revival of Police Order Amendment of 2002) (Amendment) Act; 2019, hereinafter referred to as the said Act, Sindh throughout the Act, for the word "Article" wherever appearing, the word 2019. "section" shall be substituted.

3. In the said Act, in section 2 -

(a) after clause (vi), the following new clause shall be inserted:-

"(vi-a) "deceased" means a person falling within the definition of "Police or Police Establishment" who dies while in service but does not include Shaheed;";

(b) after clause (xii), the following new clause shall be inserted:-

"(xii-a) "permanently invalidated or incapacitated" means a person falling within the definition of "Police or Police Establishment" who is declared invalidated or incapacitated by the Medical Board;";

(c) after clause (xxv), the following new clause shall be inserted:-

"(xxv-a) "Shaheed" shall have the same meaning as assigned to it under the Sindh Shaheed Recognition and Compensation Act, 2014 (Sindh Act No.XVI of 2014);".

 In the said Act, in section 7, for sub-section (3), the following shall be A substituted:-

Amendment of section 7 of Sindh Act No.XI of 2019.

Amendment of section 2 of Sindh Act No.XI of 2019.

"(3) The direct recruitment in the police other than Ministerial and Specialist Cadres shall be in the ranks of Constable, Assistant Sub-Inspector, Inspector and Deputy Superintendent:

Provided that the selection for direct recruitment in the rank of Assistant Sub-Inspector, Inspector and Deputy Superintendent shall be as per quota and manner notified by the Government from time to time through Sindh Public Service Commission except against Shaheed, deceased, permanently invalidated or incapacitated quota in the rank of Assistant Sub-Inspector:

Provided further that the recruitment in the rank of Shaheed, deceased, permanently invalidated or incapacitated quota in the rank of Assistant Sub-Inspector shall be done expeditiously through a competitive process as may be prescribed.".
