NO.PAS/LEGIS-B-38/2021-The Education City (Amendment) Bill, 2021 having been passed by the Provincial Assembly of Sindh on 25th November, 2021 and assented to by the Governor of Sindh on 17th December, 2021 is hereby published as an Act of the Legislature of Sindh.

THE EDUCATION CITY (AMENDMENT) ACT, 2021

SINDH ACT NO. XXXVII OF 2021.

AN

to amend the Education City Act, 2013.

WHEREAS it is expedient to amend the Education Preamble. City Act, 2013, in the manner hereinafter appearing;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Education City Short title and (Amendment) Act, 2021. commencement.
 - (2) It shall come into force at once.

2. In the Education City Act, 2013, hereinafter referred to as Amendment of the said Act, in section 2 – section 2 of Since

Amendment of section 2 of Sindh Act No.XVI of 2013.

(i) clause (e) shall be omitted;

- (ii) after clause (I), the following new clauses shall be inserted:-
 - "(I-i) "Project Director" means the Project Director of the Project Implementation Unit;
 - (I-ii) "Project Implementation Unit" means the Project Implementation Unit of the Education City Project which includes the authority responsible for execution of the project headed by the Project Director and supported staff;".
- 3. In the said Act, in section 3, for sub-section (2), the Amendment of following shall be substituted:

"(2) The Board shall consist of -

- (i) Chairman, Sindh Higher Education Chairperson Commission.
- (ii) Minister or Advisor or Special Assistant Viceto Chief Minister Sindh for Chairperson Investment Department.
- (iii) One Member of National Assembly Member (MNA) of the local area to be nominated by the Chief Minister, Sindh.
- (iv) One Member of Provincial Assembly Member of Sindh (MPA) of the local area to be nominated by the Speaker, Provincial Assembly of Sindh.
- (v) Senior Member, Board of Revenue, Member Sindh.
- (vi) Secretary to Government of Sindh, Member Investment Department.
- (vii) Project Director, Education City Member/ Project. Secretary
- (viii) two stakeholders to be nominated Members by the Board.
