SINDH ACT NO. XXVII OF 2018

to amend the Sindh Sports Board Ordinance, 1980.

WHEREAS it is expedient to amend the Sindh Sports Board Preamble. Ordinance, 1980, in the manner hereinafter appearing;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Sindh Sports Board Short title and (Amendment) Act, 2018. commencement.
- (2) It shall come into force at once.

- Secretary Finance or his nominee Member not below the rank of an Additional Secretary

- (v) Commissioners of the all Divisions Members in Sindh
- (vi) Secretary (Colleges), Education Member Department or his nominee not below the rank of an Additional Secretary
- (vii) Representative of the Planning & Member Development Department not below the rank of Chief Planning Officer
- (viii) Deputy Secretary, Sports and Member Youth Affairs Department
- (ix.) Director Sports, Sindh Member
 (x) Deputy Directors (Sports) of all Members Divisions
- (xi) Representative of Sindh Olympic Member Association
- (xii) Four Representatives of Members.". associations nominated by Government
- (xiii) Two Members of the Provincial Members Assembly of Sindh are to be nominated by the Speaker.
- (ii) after sub-section (1), the following shall be inserted:-

"(1-A) The Chairman or in his absence the Vice-Chairman shall preside over the meetings of the Board."

(iii) for sub-section (2), the following shall be substituted:-

"(2) The Secretary, Sports and Youth Affairs Department and Director Sports shall be the Secretary and Joint Secretary of the Board, respectively.";

(iv) in sub-section (2-A), for the word "Governor", the words "Chief Minister" shall be substituted.
