ACT**

to amend the Provincial Motor Vehicles Ordinance, 1965.

WHEREAS it is expedient to amend the Provincial Motor Vehicles Ordinance, 1965, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

- (1) This Act may be called the Provincial Motor Vehicles (Amendment) Act, 2022.
- (2) It shall come into force at once.

**Short title and
Commencement.**

2. In the Provincial Motor Vehicles Ordinance, 1965, for section 23-A, the following shall be substituted:-

Amendment of section 23-A in the West Pakistan Ordinance No.XIX of 1965.

"23-A. **Penalty in default of registration.** If any owner of motor vehicle, imported into the country or purchased from any authorized manufacturer in the country, fails to register it within sixty days of its import, or purchase, as the case may be, he shall, besides the registration fee prescribed under the rules, be liable to a penalty as may be determined by Government from time to time."
