NO.PAS/LEGIS-B-28/2021-The Provincial Motor Vehicles (Second Amendment) Bill, 2021 having been passed by the Provincial Assembly of Sindh on 03rd August, 2022 and assented to by the Governor of Sindh on 17th August, 2022 is hereby published as an Act of the Legislature of Sindh.

THE PROVINCIAL MOTOR VEHICLES (SECOND AMENDMENT) ACT, 2021.

SINDH ACT NO. XII OF 2022

ACT

to further amend the Provincial Motor Vehicles Ordinance, 1965.

WHEREAS it is expedient to further amend the Provincial Motor Vehicles Ordinance, 1965, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Provincial Motor Vehicles (Second Amendment) Act, 2021. **Short title and commencement.**

(2) It shall come into force at once.

2. In the Provincial Motor Vehicles Ordinance, 1965, hereinafter referred to as the said Ordinance, in section 2 –

Amendment of section 2 of the West Pakistan Ordinance No. XIX of 1965.

- (i) after clause (2), the following new clause shall be inserted:-

"(2-A) "BRT" means Bus Rapid Transit vehicle operating on fixed fares for all stages;

- (ii) after clause (5), the following new clause shall be inserted:-

"(5-A) "Corridor" means a way for operation of BRT vehicles."

3. In the said Ordinance, in section 23, in sub-section (1), the full stop at the end shall be replaced by a colon and thereafter the following proviso shall be added:-

Amendment of section 23 of the West Pakistan Ordinance No. XIX of 1965.

"Provided that the BRT vehicle shall operate with convoy numbers assigned by the Sindh Mass Transit Authority established under the Sindh Mass Transit Authority Act, 2014."

4. In the said Ordinance, in section 39, after sub-section (3), the following new sub-section shall be added:-

Amendment of section 39 of the West Pakistan Ordinance No. XIX of 1965.

"(4) The provisions of sub-section (1) shall not apply to any BRT vehicles operated through Sindh Mass Transit Authority."

5. In the said Ordinance, in section 44, in sub-section (3), after clause (h), the full stop at the end shall be replaced by a semi-colon and thereafter the following new clause shall be inserted:-

Amendment of Section 44 of West Pakistan Ordinance No. XIX of 1965.

"(i) to any Bus Rapid Transit operated through Sindh Mass Transit Authority."
