NO.PAS/Legis-B-23/2011- The Sindh (Repeal of the Police Order, 2002 and Revival of the Police Act, 1861) Bill, 2011 having been passed by the Provincial Assembly of Sindh on 13th July, 2011 and assented to by the Governor of Sindh on 14th July, 2011 is hereby published as an Act of the Legislature of Sindh.

**THE SINDH (REPEAL OF THE POLICE ORDER, 2002
AND REVIVAL OF THE POLICE ACT, 1861) ACT, 2011.**

SINDH ACT NO. XXII OF 2011

**AN
ACT**

to repeal the Police Order, 2002 (Chief Executive's Order No. XXII of 2002) and revive the Police Act, 1861 (Act No. V of 1861).

WHEREAS it is expedient to repeal the Police **Preamble.**
Order, 2002 (Chief Executive's Order No. XXII of 2002)
and revive the Police Act, 1861 (Act No. V of 1861).

It is hereby enacted as follows :-

Short title and commencement.

1.(1) This Act may be called the Sindh (Repeal of the Police Order,2002 and Revival of the Police Act,1861) Act,2011.

(2) It shall come into force at once.

Revival of Act No.V of 1861.

2. The Police Act,1861 (Act No.V of 1861) as it stood on 13th August,2002, is hereby revived with immediate effect as if it had never been repealed.

Repeal of Chief Executive Order No.XXII of 2002.

3. The Police Order,2002 (Chief Executive's Order No.XXII of 2002) to the extent of its application to the Province of Sindh is hereby repealed with immediate effect.

Saving.

4. Notwithstanding the repeal of the Police Order,2002 (Chief Executive's Order No.XXII of 2002), all orders made (including rules, bye-laws, regulations and notifications and other legal instruments), proceedings taken, appointments made, acts done by any authority or any person, which were made, taken or done, or purported to have been made, taken or done thereunder, between the 14th day of August,2002 and the date on which this Act comes into force (both days inclusive), shall continue to remain in force, until altered, repealed or amended by the Chief Minister or any authority or officer, authorized by him.

5. If any difficulty arises in giving effect to the provisions of this Act, the Chief Minister may, by notification in the official gazette, make such provisions as appear to be necessary or expedient for removing the difficulty. **Removal of difficulty.**

6. The Sindh (Repeal of the Police Order, 2002 and Revival of the Police Act, 1861) Ordinance, 2011 is hereby repealed. **Repeal.**
