NO.PAS/Legis-B-18/2011- The Zulfikarabad Development Authority (Amendment) Bill, 2011 having been passed by the Provincial Assembly of Sindh on 8th June, 2011 and assented to by the Governor of Sindh on 28th June, 2011 is hereby published as an Act of the Legislature of Sindh.

THE ZULFIKARABAD DEVELOPMENT AUTHORITY (AMENDMENT) ACT, 2011.

SINDH ACT NO. XXI OF 2011

AN ACT

to amend the Zulfikarabad Development Authority Act, 2010.

WHEREAS it is expedient to amend the Zulfikarabad Development Authority Act, 2010; in the manner hereinafter appearing; Preamble.

It is hereby enacted as follows:-

1. (1) This Act may be called the Zulfikarabad Development Authority (Amendment) Act, 2011. Short title and commencement.

(2) It shall come into force at once.

2. In the Zulfikarabad Development Authority Act, 2010, in section 5, for sub-section (1), the following shall be substituted:-

“(1) The Authority shall perform the functions and exercise the powers through Governing Body which shall consist of -

(a)	Chief Minister	Chairman
(b)	Three Members of the Provincial Assembly of Sindh to be nominated by Government	Members
(c)	Chief Secretary	Member
(d)	Additional Chief Secretary, Planning and Development	Member
(e)	Senior Member, Board of Revenue	Member
(f)	Secretary Finance	Member
(g)	Secretary Local Government	Member
(h)	Member Land Utilization, Board of Revenue	Member
(i)	Managing Director	Member
(j)	Chief Executive Officer Sindh Land Management and Development Company	Member

(1-a) The Chief Minister may in his discretion appoint any member or person as Vice Chairman of the Governing Body who shall, inter-alia, chair the meetings of the Governing Body in the absence of the Chief Minister.

(1-b) The Chief Minister may in his discretion appoint any member or person as Secretary of the Governing Body.”.

3. The Zulfikarabad Development Authority (Amendment) Ordinance, 2011 is hereby repealed. **Repeal.**
