**PROVINCIAL ASSEMBLY OF SINDH

KARACHI, THE 13TH JUNE, 2023**

NO.PAS/LEGIS-B-02/2023-The Provincial Assembly of Sindh in its sitting held on 13th February, 2023 passed the Isra University (Amendment) Bill, 2023 and was sent to the Governor for accord his assent as required under clause (2)(a) of Article 116 of Constitution of the Islamic Republic of Pakistan, 1973 but he, instead of accord assent to the Bill, returned the same with message in exercise of powers vested upon him under clause 2(b) of Article 116 of the Constitution.

The Provincial Assembly of Sindh in its sitting held on 17th May, 2023 reconsidered the Bill under clause (3) of Article 116 of the Constitution and passed the same thereof which was again sent to the Governor for assent.

The period of ten days has been elapsed and the subject bill shall be deemed to have been assented by the Governor under clause (3) of Article 116 of the Constitution and is hereby published as an Act of the Legislature of Sindh.

THE ISRA UNIVERSITY (AMENDMENT) ACT, 2023.

WHEREAS it is expedient to amend the Isra Preamble. University Act, 1997, in the manner hereinafter appearing.

It is enacted as follows:-

1. (1) This Act may be called the Isra University (Amendment) Act, 2023. Short title and commencement.

(2) It shall come into force at once.

2. In the Isra University Act, 1997, hereinafter referred to as the said Act, in section 3, for sub-section (2), the following shall be substituted:- Amendment of section 3 of Sindh Act No.V of 1997.

"(2) The University shall be a body corporate by the name of the Isra University having perpetual succession and a common seal, with power, among others to acquire, hold and dispose of any property movable or immovable vesting in it and shall by the said name, sue and be sued."

3. In the said Act, in section 7, for sub-section (1), the following shall be substituted:- Amendment of section 7 of Sindh Act No.V of 1997.

"(1) The Chancellor shall be appointed by the Foundation from amongst the panel of three persons of eminence in letters, sciences or social work, recommended by the Board, for a period of three years, which may be extended by the Foundation for such further period and on such terms and conditions as the Board may determine."

4. In the said Act, in section 8, for sub-section (1), the following shall be substituted:- Amendment of section 8 of Sindh Act No.V of 1997.

"(1) The Vice Chancellor shall be appointed by the Chancellor on the recommendations of the Board, for a period of three years, which may be extended by the Chancellor for such further period and on such terms and conditions as the Board may determine."

5. In the said Act, in section 16, in sub-section (1), in clause (vii), after the word "Foundation", the words "who shall not be the Directors, office bearers or members of the Foundation" shall be added. Amendment of section 16 of Sindh Act No.V of 1997.

6. In the said Act, in section 24, in sub-section (1), in the second proviso, for the word "Foundation", the word "Chancellor" shall be substituted. Amendment of section 24 of Sindh Act No.V of 1997.

7. In the said Act, in section 26, in sub-sections (2), after the words "met from", the words "its own resources and/or from" shall be inserted.

Amendment of section 26 of Sindh Act No.V of 1997.

8. In the said Act, in the First Statutes, in clause 7, in sub-clause (1)(v) and in clause 8, in sub-clause (1)(ii), after the word "Foundation", the words "who shall not be the Directors, office bearers or members of the Foundation" shall be added respectively.

The Provincial Assembly of Sindh in its session held on 13th February, 2023 reconsidered the Bill under clause (2) of Article 115 of the Constitution and passed the same without any amendment in the Constitution of Sindh.

The period of six days has been observed and the subject will be referred to the Governor for his assent. The Governor under clause (3) of Article 115 of the Constitution and
