NO.PAS/LEGIS-B-12/2019-The Sindh Consumer Protection (Amendment) Bill, 2019 having been passed by the Provincial Assembly of Sindh on 12th July, 2023 and assented to by the Governor of Sindh on 04th August, 2023 is hereby published as an Act of the Legislature of Sindh.

THE CONSUMER PROTECTION (AMENDMENT) ACT, 2019

SINDH ACT NO. XXIX OF 2023.

AN ACT

to amend the Sindh Consumer Protection Act, 2014.

WHEREAS it is expedient to amend the Sindh Consumer Preamble. Protection Act, 2014, in the manner hereinafter appearing;

It is hereby enacted as follows:-

INCIAL ASSEMBLY OF SINDH

- 1. (1) This Act may be called the Sindh Consumer Protection Short title and commencement. (Amendment) Act, 2019.
- (2) It shall come into force at once.

In the Sindh Consumer Protection Act, 2014, hereinafter referred Amendment of to as the said Act, in section 2-

section 2 of Sindh Act No.XVII of 2015.

- (i) after clause (d), the following shall be inserted:-
 - "(dd) "Consumer Court" means the Consumer Protection Court established under section 27:";

(ddd) "complaint" shall have the same meaning as assigned to it under clause (h) of section 2 of the Code of Criminal Procedure, 1898 (Act V of 1898);

- after clause (e), the following shall be inserted:-
 - "(ee)" "claim" means the case of the consumer setup in the shape of complaint;".

PROVINCIAL ASSEMBLY OF SINDH MOTTADIBITON

In the said Act, in section 30, for the words "at the pre-trial Amendment of stage", wherever occurring, the words "at any stage of trial" and for section 30 of the word "Consumer Council", the word "Consumer Court" shall Sindh Act respectively be substituted.

In the said Act, in section 34, for the words "Sindh High Court", Amendment of the words "District and Sessions Court" shall be substituted.
