**NO.PAS/LEGIS-B-10/2022-**The Stamp (Sindh Amendment) Bill, 2023 having been passed by the Provincial Assembly of Sindh on  $17^{th}$  July, 2023 and assented to by the Governor of Sindh on  $05^{th}$  August, 2023 is hereby published as an Act of the Legislature of Sindh.

THE STAMP (SINDH AMENDMENT) ACT, 2023

SINDH ACT NO. XXVI OF 2023.

ACT

to amend the Stamp Act 1899, in its application to the Province of Sindh.

WHEREAS it is expedient to amend the Stamp Act 1899, Preamble. in its application to the Province of Sindh, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Stamp (Sindh Amendment) Act. Short title and 2023.

commencement.

- (2) It shall come into force at once.
- In the Stamp Act, 1899, hereinafter referred to as the said Amendment of Act Act, throughout the Act, for the word "Provincial Government", No.II of 1899. the word "Government" shall be substituted.

In the said Act, in section 1, in sub-section (2), for the word "Pakistan", the word "Sindh" shall be substituted.

  - (9A) "Commissioner" means a Commissioner of a Division appointed under the Sindh Land Revenue Act, 1967 (Act XVII of 1967) and includes an Additional Commissioner;";
