

SIND ORDINANCE NO. IV of 1971
THE WEST PAKISTAN URBAN IMMOVABLE PROPERTY TAX ACT
(SIND AMENDMENT) ORDINANCE, 1971.

[19th March, 1971]

An Ordinance to amend the West Pakistan Urban Immovable Property Tax Act, 1958, in its application to the Province of Sind.

WHEREAS it is expedient to amend the West Pakistan Urban Immovable Property Tax Act, 1958, in its application to the Province of Sind, in the manner hereinafter appearing;

Preamble.

NOW, THEREFORE, in pursuance of the Martial Law Proclamation of 25th March, 1969, read with the Provisional Constitution Order, and in exercise of all powers enabling him in that behalf, the Governor of Sind and Martial Law Administrator, Zone 'D', is pleased to make and promulgate the following Ordinance :-

1. This Ordinance may be called the West Pakistan Urban Immovable Property Tax Act (Sind Amendment) Ordinance, 1971.

Short title

2. In the West Pakistan Urban Immovable Property Tax Act, 1958, in its application to the Province of Sindh, hereinafter referred as the said Act, in the long title and preamble, for the words "West Pakistan", the word "Sind" shall be substituted.

Amendment of long title and preamble to W.P. Act V of 1958.

3. In section 1 of the said Act-

Amendment of section 1 of W.P. Act V of 1958

(a) in sub-section (1), for the words "West Pakistan", the word "Sind" shall be substituted; and

(b) for sub-section (2), the following sub-section shall be substituted, namely:-

"(2) It extends to the whole of the Province of Sind."

4. In section 2 of the said Act—

Amendment of section 2 of W.P. Act V of 1958.

(a) in clause (d), for the words "West Pakistan", the word "Sind" shall be substituted; and

(b) for clause (dd), the following clause shall be substituted, namely:---

"(dd) 'members of the family of the owner' means his or her—

- (i) wife or husband, as the case may be; and
- (ii) dependent children;'

5. In section 4 of the said Act, in sub-clause (i) of clause (b), for the words "Government of West Pakistan", the words "any Provincial Government" shall be substituted. **Amendment of section 4 of W.P Act V of 1958**
6. In section 23 of the said Act, in sub-section (4), the words "of West Pakistan" shall be omitted. **Amendment of section 23 of W.P Act V of 1958**
7. Section 24 of the said Act shall be omitted. **Omission of section 24 of W.P Act V of 1958.**
