THE WEST PAKISTAN BOARD OF REVENUE (SIND AMENDMENT) ORDINANCE, 1970

[30th July, 1970] An Ordinance to amend the West Pakistan Board of Revenue Act, 1957, in its application to the Province of Sind. **WHEREAS** it is expedient to amend the West Pakistan Board **Preamble**. of Revenue Act, 1957, in its application to the Province of Sind, in the manner hereinafter appearing; NOW, THEREFORE, in pursuance of the Martial Law Proclamation of 25th March, 1969, read with the Provisional Constitution Order, and in exercise of all powers enabling him in that behalf, the Governor of Sind is pleased to make and promulgate the following Ordinance :-1. (1) This Ordinance may be called the West Pakistan Board of Short title and Revenue (Sind Amendment) Ordinance, 1970. commencement. (2) It shall be deemed to have come into force on and from 1st July, 1970. In the West Pakistan Board of Revenue Act, 1957, in its Substitution 2. of application to the Province of Sind, hereinafter referred to as "West Pakistan" the said Act, for the words "West Pakistan", wherever by "Sind" in W.P. appearing, except in sub-section (1) of section 1, the word, Act XI of 1957.
