### THE SIND PUBLIC SERVICE COMMISSION ORDINANCE, 1973

[7<sup>th</sup> September, 1973]

**An Ordinance** to provide for a Public Service Commission for Sind.

WHEREAS it is expedient to provide for a Public Service Preamble. Commission for Sind and matters ancillary thereto;

**AND WHEREAS** The Provincial Assembly is not in session and the Governor of Sind is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Sind is pleased to make and promulgate the following Ordinance:-

- This Ordinance may be called the Sind Public Short title and (1) Service Commission Ordinance, 1973.
  - commencement.

- It shall come into force at once. (2)
- 2. In this Ordinance, unless there is anything repugnant in the subject or context,—
  - (a) "Commission" means the Sind Public Service Commission established under this Ordinance:
  - "Government" means the Government of Sind: (b)
  - "Member" means a Member of the Commission (C) and, unless the context otherwise requires, includes the Chairman thereof; and
  - "prescribed" means prescribed by rules made (d) under this Ordinance.
- There shall be a Public Service Commission for the Composition of 3. (1) Province of Sind consisting of three Members to be appointed Commission. by Government, provided that Government may at any time increase the number of Members for such period as it may determine and may appoint one or more persons in the Service of Pakistan to be Members ex-officio for the discharge of such functions as Government may determine.

(2)Government shall nominate one of the Members as Chairman of the Commission:

Provided that the Members and Chairman of the Sind-Baluchistan Public Service Commission appointed from the Province of Sind shall be deemed to have constituted the

Commission under this section from 14th day of August, 1973 and the actions taken and orders passed by them individually or together with the Member appointed from the Province of Baluchistan before the coming into force of this Ordinance shall be deemed to have been validly taken or passed, as the case may be.

4. A Member shall hold office for three years, Term of office of (1) provided that Government may—

- (a) extend the term of office of a Member for such period as it may determine; and
- (b) for reasons to be recorded, terminate appointment of a Member before the expiry of the term of his office.
- A Member may resign his office by writing under his (2)hand addressed to the Governor.
- The terms and conditions of service of Members (3) shall be such as may be determined by Government.
- 5. The functions of the Commission shall be—

- (a) to conduct tests and examination for recruitment to—
  - Provincial Civil Service and other civil posts in (i) connection with the affairs of the Province; and
  - such posts in or under a corporation or (ii) organization or other body set up Government under any law.

- (b) to advise Government on such matters as may be prescribed, relating to the terms and conditions of service of persons who are members of Provincial Civil Service or hold civil posts in connection with the affairs of the Province.
- Government may, by notification in the official Gazette, Power to make 6. make rules for carrying out the purposes of this Ordinance.
