THE SIND BOARDS OF INTERMEDIATE AND SECONDARY EDUCATION (AMENDMENT) ACT, 1973

[5th December, 1973]

An Act to further amend the Sind Boards of Intermediate and Secondary Education Ordinance, 1972.

WHEREAS it is expedient to further amend the Sind Preamble. Boards of Intermediate and Secondary Education Ordinance, 1972, in the manner hereinafter appearing;

It is hereby enacted as follows:-

- (1) This Act may be called the Sind Boards of Short title and 1. commencement. Intermediate and Secondary Education (Amendment) Act, 1973
 - (2) It shall come into force at once.

In the Sindh Boards of Intermediate and Secondary Amendment of 2. Education Ordinance, 1972, hereinafter referred to as the said section 2 of Sind Ordinance, in section 2 -

- for clause (b), the following shall be substituted:--(i) "(b) 'Board' means a Board constituted and established under section 3;";
- for clause (e), the following shall be substituted:--(ii)

"(e) 'Committee' means a Committee constituted under this Ordinance and, except for the purposes of sections 15 and 17, includes the Joint Academic Co-ordination Committee:"" and

in clause (u), for the words "Boards at Hyderabad (iii) Khairpur", the words "the Board and at Hyderabad" shall be substituted.

3. In the said Ordinance, for sub-section (1) of section 3, the following shall be substituted:--

> "(3) There shall be constituted and established on and from the date to be notified by Government-

(a) in Karachi –

- a Board called the Board of Secondary (i) Education, Karachi; and
- a Board called the Board of Intermediate (ii) Education Karachi: and
- (b) at Hyderabad a Board called the Board of Intermediate and Secondary Education, Hyderabad.".

- (a) the Board of Secondary Education, Karachi, the Director of School Education;

- (vi) one Headmaster or Headmistress in the case of the Board of Secondary Education, Karachi, and one Principal in other cases, to be nominated by the Controlling Authority;
- (vii) one representative of Heads of Schools elected by and from among such Heads in the case other than that of the Board of Intermediate Education, Karachi;
- (viii) one representative of Heads of Intermediate Colleges, elected by and from among such Heads, in a case other than that of the Board of Secondary Education, Karachi;".

5. In the said Ordinance, in sub-section (1) of section Ameri 9, for the words "the institutions within the territorial limits that". Section the words "such institutions within such territorial limits as" shall be substituted.

- 6. In the said Ordinance, in section 11
 - (a) in sub-section (1), for the words "and Secondary Education", the words and comma "or Secondary Education or both, as the case may be" shall be substituted;

 - (b) in sub-section (2), between the words "a Board" and the word "shall" the words "having jurisdiction" shall be inserted.

7. In the said Ordinance, for sub-section (3) of <u>Amendment of</u> section 15, the following shall be substituted:--

"(3) The Chairman shall be the principal executive and academic officer of the Board and shall, when present, preside at the meeting of the Board or a Committee.".

8. In the said Ordinance, after section 15, the following new section shall be inserted:--

Insertion of section <u>15-A in Sind</u> <u>Ordinance VI of</u> <u>1972.</u>

Joint Academic Coordination	"15-A. (1) The Academic Co-ordination Committee shall consist of the following members:
Committee.	(a) the Secretary to Government of Sind, Education Department;
	(b) the Chairman of all Boards; (c) the Directors School Education;

(d) the Directors College Education;

(e) the Director Technical Education, Sind;

(f) the Director Curriculum Development, Sind; and

(g) the Chairman, Sind Text Book Board.

(2) The Secretary to Government of Sind, Education Department shall be the Chairman of the Committee.

(3) The meetings of the Committee shall be held at lease once in a year, but the Chairman may, whenever he considers necessary and shall, on requisition of one-third members of the Committee, call a meeting of the Committee.

(4) The quorum for the meeting of the Committee shall be one-third of the total number of members, a fraction being counted as one.

(5) The Committee shall have the general superintendence and control of, and be responsible for, the maintenance of the standards of teaching and examination.

(6) Without prejudice to the generality of the foregoing provisions the Committee shall coordinate the functions of the academic committees of the Boards.

"(1) On the constitution and establishment of a Board under section 3, the following enactments shall, in relation to such Board, stand repealed:--

- (i) The Board of Intermediate and Secondary Education Hyderabad Ordinance, 1961 (West Pakistan Ordinance, XVII of 1961); and
- (ii) The Board of Intermediate and Secondary Education Karachi Ordinance, 1962 (West Pakistan Ordinance III of 1962).".

10. In the said Ordinance, in the Schedule—

 - (b) the Board of Intermediate Education, Karachi, the Director College Education; and
 - (c) the Board of Intermediate and the Secondary Education Hyderabad, the Directors of School Education and College Education;";
 - (e) in regulation 7, in paragraph (1), for clauses (ii) and (iii) the following shall be substituted:--
