## THE WEST PAKISTAN PURE FOOD (SIND AMENDMENT) ACT, 1973

[28<sup>th</sup> June, 1973]

An Act to amend the West Pakistan Pure Food Ordinance, 1960, in its application to the Province of Sind.

WHEREAS it is expedient to amend the West Pakistan Preamble. Pure Food Ordinance, 1960, in its application to the Province of Sind, in the manner hereinafter appearing;

It is hereby enacted as follows:-

- (1) This Act may be called the West Pakistan Pure Food Short title and 1. commencement. (Sind Amendment) Act, 1973.
  - (2) It shall come into force at once.

In the West Pakistan Pure Food Ordinance, 1960, in its Substitution of section 2. application to the Province of Sind, hereinafter referred to as 23 of West Pakistan Ordinance VII of the principal Ordinance, for section 23, the following section 1960. shall be substituted, namely:--

'23. (1) Whoever contravenes the provisions of Penalties. sections 12 or 21, shall be punished with imprisonment of either description for a term which may extend to three years or with fine or with both.

> Whoever contravenes the provisions of (2) sections 7, 8, 9, 10, 11 or 18, shall be punished with imprisonment of either description for a term which may extend to five years or with fine or with both but the term of imprisonment shall not be less than six months and the find shall not be less than five hundred rupees.

> (3) Whoever contravenes the provisions of sections 3,4,5,6 or 13, shall be punished with imprisonment of either description for a term which may extend to seven years and with fine, but the terms of imprisonment shall not be less than one year and the find shall not be less than thousand rupees.". one

3. Section 23-A of the principal Ordinance shall be Omission of section omitted.

For section 31 of the principal Ordinance, the Substitution of section 4. following section shall be substituted, namely:--

"31.All offences under this Ordinance shall be The procedure triable, by a Magistrate of the first class and, in for trial of accordance with the procedure prescribed by offences. Chapter XX of the Code of Criminal Procedure, 1898 (Act V of 1898):

> Provided that if in any trial before any such Magistrate, before signing judgment, it appears to him at any stage of the proceedings that the case is one in which the accused ought to receive a punishment more severe than that which such Magistrate is empowered to inflict or that the accused ought to be tried by the Court of Sessions, he shall commit the accused in accordance with the provisions of the Code of Criminal Procedure, 1898 (Act V of 1898).".

The West Pakistan Pure Food (Sind Amendment) 5. Ordinance, 1973, is hereby repealed.
