[25th August 1975]

An Act to repeal and amend certain laws in force in the Province of Sind.

WHEREAS it is expedient that certain laws, which are spent or have become un-necessary, or have ceased to be in force otherwise than by express repeal, should be expressly repealed; **Preamble**

AND WHEREAS it is further expedient that certain amendments should be made in certain laws;

It is hereby enacted as follows:—

Short title and commencement.

1. (1) This Act may be called the Sind Repealing and Amending Act, 1975.

(2) It shall come into force at once.

2. The Laws specified in the First Schedule are hereby repealed. **Repeal of certain laws.**

3. The laws specified in the third column of the Second Schedule are hereby amended to the extent and in the manner mentioned in the fourth column thereof. **Amendment of certain other laws.**
