An Ordinance to amend the West Pakistan (Board of Intermediate and Secondary Education, Karachi) Ordinance, 1962.

WHEREAS it is expedient to amend the West Pakistan Preamble. (Board of Intermediate and Secondary Education, Karachi) Ordinance, 1962, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Martial Law Proclamation of 25th March, 1969, read with the Provisional Constitution Order, and in exercise of all powers enabling him in that behalf, the Governor of Sind is pleased to make and promulgate the following Ordinance :-

- 1. (1) This Ordinance may be called the West Pakistan (Board Short title and of Intermediate and Secondary Education, Karachi) commencement. (Sind Amendment) Ordinance, 1971.
 - (2) It shall come into force at once.

2. In the West Pakistan (Board of Intermediate and Secondary Education, Karachi) Ordinance, 1962, hereinafter referred to as the principal Ordinance, in sub-section (1) of section 1, for the words, brackets and comma "West Pakistan (Board of Intermediate and Secondary Education, Karachi)", the words and comma "Board of Intermediate and Secondary Education, Karachi" shall be substituted.

 In section 2 of the principal Ordinance, in clause (g) for the words "West Pakistan", the word "Sind" shall be substituted.
 For section 5 of the principal Ordinance, the following section shall be substituted, namely: Amendment of section 2 of W.P. Ordinance III of section 5 of W.P. Ordinance III of section 5 of W.P.
