An Ordinance to amend the Sind Local Government Ordinance, 1979.

WHEREAS it is expedient to amend the Sind Local Preamble. Government, 1979, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provisional Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance:-

- 1. This Ordinance may be called the Sind Local **Short** title (1) and Government (Second Amendment) Ordinance, 1982. commencement.
 - (2)It shall come into force at once.
- 2. Sind Local Government Ordinance, Amendment the 1979hereinafter referred to as the said Ordinance, in section 3 of Sind section 3-

Ordinance XII of 1979.

- (i) in clause (9), for the words "or Chief Officer" the commas and the words ", Chief Officer, Town Officer or Secretary" shall be substituted:
- (ii) In clause (15), the comma and the words ", Taluka council" shall be omitted:
- (iii) In clause (20), for the words "and 'divisional co-ordination committee", the comma and the words ", 'divisional coordination committee' and 'taluka co-ordination committee," shall be substituted;
- (iv) In clause (63), the words "Taluka council or" shall be omitted:
- (v) Clause (68) shall be omitted;
- (vi) In clause (79), for the words "district council or", the words and commas "union council, district council, town committee or" shall be substituted.
- 3. In the said Ordinance, in section 6, the comma and Amendment section 6 of Sind the word ", taluka" shall be omitted. Ordinance XII of 1979.

In the said Ordinance, in section 21, for sub-section Amendment of (1), the following shall be substitution:section 21 of **Sind Ordinance** "(1) A member may resign his office by tendering XII of 1979. resignation in writing to the Chief Executive and his seat shall become vacant forthwith.".
 - "(1) A Mayor, Deputy Mayor, Chairman or Vice Chairman may resign his office by tendering resignation in writing to the Chief Executive and his seat shall become vacant forthwith.".

"90. The divisional, district or taluka co-ordination committee shall co-ordinate the activities of all councils and nation building **Functions** departments in the division, district or

taluka, as the case may be, and may perform such other functions as may be assigned to them by Government for the furtherance of the purposes of this Ordinance.".
