THE AGRICULTURAL PRODUCE MARKETS (AMENDMENT) ORDINANCE, 1983

[7th December, 1983]

An Ordinance to amend the Agricultural Produce Markets Act. 1939.

WHEREAS it is expedient to amend the Agricultural Preamble. Produce Markets Act, 1939, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provisional Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance:—

1. (1) This Ordinance may be called the Agricultural Short title and Produce Markets (Amendment) Ordinance, 1983.

- (2) It shall come into force at once.
- In the Agricultural Produce Markets Act, 1939, Amendment of 2. hereinafter referred to as the said Act, in section 4, for sub- Section 4 of section (2) and (3), the following shall be substituted:—

- "(2) After the date of such notification and on the establishment of a market committee under section 7, no person, notwithstanding anything contained in any other law unless exempted under this Act shall, within the notified market area, set-up or establish or use any place for the purchase, storage or sale of any agricultural produce except in accordance with the terms and conditions of licence.
- (3) Government may, in accordance with the provisions of sub-section (1) exclude any area from or include any area to, any notified market area.".
- In the said Act, in section 4-A, after the words Amendment of 3. "prescribed manner" the words "and in case such agricultural Section 4-A of produce can not be sold by open auction, it may be sold in Punjab Act V of such manner as may be prescribed" shall be added.

In the said Act, in section 6, in sub-section (1), for the **Amendment of** words "any person who wishes to work as a dealer in a notified Section 6 of market area may apply", the words "any person who works or wishes to work as a dealer in a notified market area shall apply" shall be substituted.

5. In the said Act, in section 8, in sub-section (3)— Amendment of Section 8 of Punjab Act V of 1939.

- (i) in sub-clause (i) of clauses (a) and (b), for the word "district" the words "notified market area" shall be substituted:
- (ii) in sub-clause (iii) of clauses (a) and (b), the word "preferably" shall be omitted.
- In the said Act, in section 16, in sub-section (3), for the **Amendment of** figure "10" the figure "11" shall be substituted.

7. In the said Act, in section 19Amendment of Section 19 of 1939.

- (a) in sub-section (1), for the words "it may fix but such Punjab Act V of rate shall not exceed maximum rate", the words "may be" shall be substituted;
- (b) in sub-section (2), for the words, figure and bracket "Twenty percent of the fee under sub-section (1)" the words "Fifteen percent of the total income of the market committee" shall be substituted.
- 8. In section 24-A—

Amendment of Section 24-A of Puniab Act V of 1939.

- (a) in sub-section (1), for the word "Government", the words and commas "Director General, Bureau of Supply and Prices, Sind" shall be substituted;
- (b) in sub-section (3), for the words "Provincial Government" the words and commas "Director General, Bureau of Supply and Prices, Sind" shall be substituted:
- (c) sub-section (4) shall be omitted.

9. In the said Act, in section 26, in sub-section (3), before Amendment of the full-stop, the words "and in case of default in payment of Section 26 of fine the convict shall be further punished to suffer simple Punjab Act V of imprisonment for a period not exceeding one month" shall be added.

10. In the said Act, in section 27, in sub-section (2)— Amendment of Section 27 of 1939.

- (a) in clause (vii), the word "maximum" shall be Punjab Act V of omitted: and
- (b) in clause (xix), after the word "market" the words "and in case where such agriculture produce cannot be sold by auction, the manner in which it may be sold" shall be added.
- 11. In the said Act, in section 28, in sub-section (1), for the **Amendment of** words "fifty rupees" occurring at the end, the words "five hundred rupees" shall be substituted.

12. In the said Act, in section 32, for the word Amendment of "Commissioner" the words and commas "Director General, Bureau of Supply and Prices, Sind" shall be substituted.

13. In the said Act, after section 33, the following section shall be added:—

Addition of new section 34 to Punjab Act V of 1939.

"34. Where any land is required by a market committee

for carrying out any of its functions under this Act, it shall be acquired under the land Acquisition Act, 1894, and the market

committee shall with the prior approval of the Director General Bureau of Supply and Prices, Sind, move the Government for acquisition of the land.".
