# THE SIND PARLIAMENTARY SECRETARIES (SALARIES, ALLOWANCES AND PRIVILEGES) ACT, 1974.

**An Act** to provide the salaries, allowances and privileges of the Parliamentary Secretaries.

WHEREAS it is expedient to provide for the salaries, Preamble. allowances and privileges of the Parliamentary Secretaries;

It is hereby enacted as follows: —

- (1) This Act may be called the Sind Parliamentary Short title and Secretaries (Salaries, Allowances and Privileges) Act, 1974. commencement.
  - (2) It shall come into force at once.
- 2. In this Act, unless the context otherwise requires, the **Definitions**. following expressions shall have the meanings hereby respectively assigned to them, that is to say—

- (a) "Assembly" means the Provincial Assembly of Sind;
- (b) "Parliamentary Secretary" means the Parliamentary Secretary appointed as such by the Chief Minister;
- (c) "Session" means the period commencing from the date of the first sitting of the Assembly, after it has been summoned, and ending on its prorogation or dissolution.
- 3. 1 A Parliamentary Secretary shall be entitled to-

- a salary of ten thousand one hundred and ninety rupees per month; and
- (ii) an orderly allowance of one thousand rupees per month upto and inclusive of 31st August, 1995 and one thousand and six hundred rupees per month with effect from 1st September, 1995.
- (iii) the use of an official car of 1300 cc (indigenously manufactured) with a Driver maintained at Government expense.".1

A Parliamentary Secretary shall be entitled to a daily **Daily Allowance**. allowance of <sup>2</sup>[one hundred and twenty five rupees] per day for two days immediately before and two days after the Session and rupees Seventy five per day during such Session.

**Explanation**.— Not more than one daily allowance shall be admissible for a single day.

1**[**4-A. (1) A Parliamentary Secretary shall provided with an official residence free of rent.

Accommodation.

- (2)Where the Parliamentary Secretary is not provided with an official residence or prefers to reside in private residence, he shall be paid house rent at the rate of 'Iforty five percent of the minimum of BS-21 as Admissible in 1991."
- 4-B. A Parliamentary Secretary shall be entitled to the-

Other facilities.

- (i) services of a whole time Steno-typist and a Naib Qasid:
- <sup>2</sup>[telephone facilities at residence and office at (ii) Government expense at the same scale as is admissible to an officer of BS-21."1.
- 4-C. (1) Leave of absence may be aranted parliamentary Secretary by the Chief Minister at a time or from time to time, for reasons of health or private affairs, for an aggregate period not exceeding three months during the whole term of his office.

- A Parliamentary Secretary shall be entitled to leave allowance equal to his salary.
- 4-D. (1) A Parliamentary Secretary shall be entitled to draw Travelling Allowance the travelling allowance for performing any journey in connection with his official duties as Parliamentary Secretary at the same scale as is admissible to <sup>3</sup>["an officer of BS-21"]

- The Minister with whom the Parliamentary Secretary is attached, shall be the Controlling Authority for the purposes of Travelling Allowances".]
- 4["4-E. A Parliamentary Secretary shall entitled to the medical reimbursement facilities as admissible to an officer of BS-21".1
