SIND ORDINANCE NO. XIII OF 2000. THE SINDH LOCAL GOVERNMENT ELECTIONS (AMENDMENT) ORDINANCE, 2000.

[14th November, 2000]

An Ordinance to amend the Sindh Local Government Elections Ordinance, 2000.

WHEREAS, it is expedient to amend the Sindh Local **Preamble**. Government Elections Ordinance, 2000, in the manner hereinafter appearing;

AND WHEREAS, in pursuance of the Proclamation of Emergency dated 14th October, 1999, and under Article 3 (2) of the Provisional Constitution Order No. 1 of 1999, dated 14th October, 1999, the Governor of a Province is to act on the instructions of the Chief Executive;

AND WHEREAS, under Article 4 of the Provisional Constitution (Amendment) Order No. 9 of 1999, the Governor of a Province may, on the instructions of the Chief Executive of Pakistan, issue and promulgate an Ordinance;

AND WHEREAS, under the Local Government Elections Order, 2000 (No. 8 of 2000), the Chief Executive of Pakistan has been pleased to empower the Chief Election Commissioner to conduct local government elections in the Provinces;

AND WHEREAS, the Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the aforesaid powers and all other powers enabling him in this behalf, the Governor of the Sindh Province, on the instructions of the chief Executive of Pakistan, is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Sindh Local Short title and
Government Elections (Amendment) Ordinance, 2000.Short title and
commencement.

(2) It shall come into force at once.

"9, Special minority seats, In a local area where the population of minorities is in excess of ten percent of the total population of that area, the seats mentioned in the preceding sections shall be allocated in such manner as the Government may determine.".

"(2) The union shall be the multimember ward for election of members of a union council, other than Union Nazim and Naib Nazim.": and

(ii) sub-section (3) shall be omitted.
