### THE SINDH PRIVATE SECURITY AGENCIES (REGULATION AND CONTROL) ORDINANCE, 2001

[3<sup>rd</sup> January,2001]

An Ordinance to provide for regulation and control of private security agencies in the province of Sindh.

**WHEREAS,** it is expedient to provide for regulation and control of private **Preamble.** security agencies and to provide for matters ancillary thereto.

**AND WHEREAS** the Provincial Assembly stands suspended in pursuance of the Proclamation of the fourteenth day of October, 1999, and the Provisional Constitution Order No. I of 1999;

**AND WHEREAS** the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

**NOW, THEREFORE** in pursuance of the aforesaid proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No. 9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

	(a)	"agency" means a private security agency carrying on the business of providing for consideration security guards or security arrangements and includes any branch of such agency;	
	(b)	"Government" means the Government of Sindh;	
	(c)	"licence" means a licence granted under this Ordinance for carrying on the business of an agency;	
	(d)	"licensee" means a holder of a licence;	
	(e)	"Licensing Authority" means the Licensing Authority appointed under this Ordinance;	
	(f)	"rules" means made under this Ordinance;	
	(g)	"security guards" includes a watchman engaged by the licensee under the rules.

(5) The licence issued under sub-section (4) shall be valid for one year and be renewable on an application in the form and on payment of the prescribed fee.			
(6) The Licensing Authority shall maintain a register containing such particulars s may be prescribed, of the licences issued under sub-section (4).			
(1) An agency not in existence on the coming into force of this Ordinance shall be established only after a licence has been issued under sub-section (4) of section 5.	Establishment and continuance of an Agency.		
(2) An agency already in existence shall not be continued for more than six months from the commencement of this Ordinance, unless an application for licence has been made within thirty days of such.			
(3) Where any application as aforesaid has been made in respect of an existing agency and such application is rejected, then, notwithstanding the period of six months provided in sub-section (2), the agency may be continued for a period of thirty days from the date on which the application is rejected, or if an appeal is preferred unit such appeal is dismissed.

(b) Furnish to the Licensing Authority such particulars with regard to personnel employed by it or its accounts, or other records or such other information as the Licensing Authority may from time to time require.

(2) The Licensing Authority, or any officer duly authorized by it in this behalf, may at all reasonable times inspect the premises of the licensee, books of account and other records of the licensee, including the record of the persons employed by the licensee, the securities, cash and other propertied held by the agency, and all documents relating thereto.

No amendment of the constitution of a licensee shall be valid unless it has (1)Amendment of been approved by the Licensing authority, for which purpose a copy of the amendment the constitution shall be forwarded to the Licensing authority. of the licensee.

(2) If the Licensing Authority is satisfied that any amendment of the constitution is not contrary to any of the provisions of this Ordinance or the rules, it may, if it thinks fit, approval the amendment.

If after making such inquiries as it may think fit, the Licensing Authority is Revocation of satisfied that the licensee has failed to comply with the provisions of this Ordinance or license. rules or condition of the license, or functioning as an organization formation of which is prohibited by law, it may by order in writing revoke the licence.

Provided that an order of revocation shall not be passed unless the licensee has been given reasonable opportunity of showing cause.

If the Licensing Authority rejects the application for licence or revokes the Appeal. licence, the applicant or, as the case may, be the licensee may, within thirty days from the date of the order of the Licensing Authority prefer and appeal to Government and the order passed by Government shall be final and given effect to by the Licensing Authority. **Penalties**

#### (1) Any person who:-

contravenes any of the provisions of this Ordinance, or any rule or (a) order made thereunder: or

(b) in an application for a licence under this Ordinance or in any report or statement submitted to the Licesing Authority, makes any false statement or false representation;

shall be punishable with imprisonment for a term, which may extend to two years, or with fine, which may extend to fifty thousand rupees, or with both.

(2) where the person committing an offence under this Ordinance is a company, or other body corporate, or an association of persons, every director, manager, secretary and other officer thereof shall, unless he proves that the offence was committed without his knowledge or consent, be deemed to be guilty of such offence.

No Court shall take cognizance of an offence under this Ordinance expect upon a complaint in writing made by the Licensing Authority, or any officer authorized by it in this behalf.

(4)All offenses under this Ordinance shall be triable by the Executive Magistrates.

## ORDINANCE, 2001

- 13. No suit, prosecution or other legal proceedings shall lie against any person for **Indemnity.** anything, which is in good faith done or intended to be done under this Ordinance.
- 14. Government may, by notification in the official Gazette, delegate all or any of its **Delegation of** powers under this Ordinance, either generally, or in respect of such agency or class of **powers.** agencies as may be specified in the notification, to any of its officers.
- 15. (1) The provisions of this Ordinance shall be in addition to and not in derogation Additional of the provisions of any other law for the time being in force. Additional provisions.

(2) Nothing in this Ordinance shall be construed as conferring on a licensee or his employee any of the powers by any law are conferred upon or exercisable by a police officer, or any other public servant.
