## **SINDH ORDINANCE NO. XXXIII OF 2001** THE SINDH URBAN STATE LAND (CANCELLATION OF ALLOTMENTS, **CONVERSIONS AND EXCHANGES) (AMENDMENT) ORDINANCE, 2001.**

An Ordinance to amend the Sindh Urban State Land (Cancellation of Allotments, Conversions and Exchanges) Ordinance, 2001.

WHEREAS it is expedient to establish to amend the Sindh Urban Preamble. State Land (Cancellation of Allotments, Conversions, and Exchanges) Ordinance, 2001, in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly stands dissolved in pursuance of the Proclamation of the fourteenth day of October, 1999 and the Provisional Constitution Order No.1 of 1999;

AND WHEREAS, the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No.9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance :-

1. This Ordinance may be called the Sindh Urban State Land Short title and (1)(Cancellation of Allotments, Conversions and Exchanges) (Amendment) commencement. Ordinance, 2001.

2. In the Sindh Urban, State Land (Cancellation of Allotments, (1)**Amendment** of the Conversions and Exchanges) Ordinance, 2001, hereinafter referred to as the said Ordinance, for the words "urban state land" wherever occurring, the words "Government Land" shall be substituted.

In the said Ordinance, in section 3, for the words "shall stand 3. cancelled", the words "including the subsequent transaction in respect thereof shall stand cancelled "shall be substituted.
