# NOTIFICATION

NO.SO(ACD-II)9-6/2002. In exercise of the powers conferred by section 7 of the Sindh Compulsory Primary Education Ordinance, 2001, the Government of Sindh is pleased to make the following rules namely:-

- 1. (i) These rules may be called the Sindh Compulsory Short title and commencement.
  - (ii) They shall come into force at once.
- 2. (1) In these rules, unless there is anything repugnant **Definition**. in the subject or context-
  - (a) "Council" means a Council constituted under the Sindh Local Government Ordinance, 2002;
  - (b) "form" means a form appended to these rules;
  - (c) "Ordinance" means the Sindh Compulsory Primary Education Ordinance, 2001.

(2) The words or expressions used but not defined in these rules shall have the same meaning as assigned to them under the Ordinance.

- 3. The Authority shall be responsible for proper implementation of the Ordinance in its jurisdiction.
- 4. The Authority shall, for the proper implementation of the Ordinance, direct the Primary schools within its jurisdiction to maintain record of the birth of the children within the catchments area of such schools in collaboration with the council concerned.
- 5. (1) The Authority shall appoint a teacher of a primary school as an Attendant ordinarily having at least ten years experience as such.

(2) The Attendant shall ensure regular attendance of the students enrolled in the school.

(3) If any student is found absent from school without sufficient excuse the Attendant shall advise his parents/guardian/employer to ensure regular attendance of their child in the school failing which the matter will be reported to the Authority through the Head of school.

6. (1) The Authority or any person authorized by it in this behalf shall from time to time inspect primary schools, within its jurisdiction.

(2) Without prejudice to the generality of sub-rule (1), the inspection may include ascertainment of the following matters:-

- (a) whether the instructions are being imparted satisfactorily according to the curricula, books and standard of teaching;
- (b) whether the Provisions of the Ordinance are being properly implemented;
- (c) whether the proper records of the working of school is being properly maintained;
- (d) whether the instructions issued from time to time by Government or the competent authority are being carried out;
- (e) whether the school leaving certificate has been issued to a student after the student has completed his Primary education or where the certificate is issued before completion of the primary education, it is issued after obtaining NOC from the new primary school in which the student is to be re-admitted.
- 7. In addition to the above, the functions of the Authority shall also be:-
  - (i) to ensure regular attendance of a child in a primary school within its area and for the purpose may issue noticed to the parents in form "A" and pass Orders in form "B";
  - (ii) to fulfill any obligation and discharge any duty imposed under the Ordinance;
  - (iii) to maintain record of its working and prepare periodical reports about the progress of Primary education in its area for submission to Government;

- (iv) to cause general superintendence of the primary schools in its area;
- (v) to comply with the directions of Government issued from time to time;
- (vi) to submit such information or returns as required by Government;
- (vii) to advise Government on matter relating to primary education and its promotion within the area of its jurisdiction;
- (viii) to prepare development plans for primary education in its area.

NOW, THEREFORE, in exercise of the powers conferred by sub-section (3) of section 5 of the Sindh Compulsory Primary Education Ordinance, 2001, you are hereby directed to cause the admission of your aforesaid child to attend the primary school within 15 days of the date of issue of this order failing which you shall be liable to be prosecuted in a Court of Law.
