## SINDH ORDINANCE NO.XI OF 1974

## THE WEST PAKISTAN GOVERNMENT EDUCATIONAL AND TAINING INSTITUTIONS (SIND **SECOND AMENDMENT) ORDINANCE, 1974**

[17<sup>th</sup> August, 1974]

An Ordinance to further amend the West Pakistan Government Educational and Training Institutions Ordinance, 1960, in its application to the Province of Sind.

WHEREAS it is expedient to further amend the West Preamble. Pakistan Government Educational and Training Institutions Ordinance, 1960, in its application to the Province of Sind, in the manner hereinafter appearing;

**AND WHEREAS** The Provincial Assembly is not in session and the Governor of Sind is satisfied that circumstances exist which render it necessary to take immediate action;

**NOW, THEREFORE**, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Sind is pleased to make and promulgate the following Ordinance:-

(1) This Ordinance may be called the West Pakistan Short title and 1. Government Educational and Training Institutions (Sind Second commencement. Amendment) Ordinance, 1974.

- (2) It shall come into force at once.
- 2. In the West Pakistan Government Educational and Amendment of Training Institutions Ordinance, 1960 (hereinafter referred to as the Principal Ordinance), in its application to the Province of Sind, in the long title and preamble, the word "Government" shall be omitted.

3. In the Principal Ordinance, in section 1—

- (a)in sub-section (1), the word "Government" shall be omitted: and
- for sub-section (2), the following sub-section shall (b) be substituted:-
  - "(2) It shall apply to such institution and from such date, hereinafter referred to as the said date, as may be notified by Government".

In the Principal Ordinance, in sections 4 and 5, for the Amendment of 4. words "the Governor", the word "Government" shall be substituted.

sections 4 and 5 of **West Pakistan** Ordinance XI OF 1960.

5. In the Principal Ordinance, for section 9, the following Substitution of section shall be substituted, namely:-

section 9 of West **Pakistan** Ordinance XI OF 1960.

Transitional provisions regarding staff.

"9. Every person serving I an institution shall, unless Government in the public interest directs otherwise, become an employee of the Board on and from the said date on such terms and conditions as may be prescribed, which shall not be less favourable than those admissible to him immediately before the said date".

> Substitution of section 10 of West **Pakistan** Ordinance XI of 1960.

In the principal Ordinance, for section 10, the following section shall be substituted, namely:-

"10. (1) All Property, movable or immovable, Property. attached to the institution immediately before the said date, shall vest in the Board.

- (2) If Government rescinds the notification issued under sub-section (2) of section 1, the property vesting in the Board shall, unless Government in the public interest directs otherwise, stand transferred to Government or as the case may be, to the institution.".
- 7. In the Principal Ordinance, in sub-section (2) of section 11, the fullstop appearing at the end of clause (e) shall be replaced by the semi-colon, and thereafter the following new clause shall be added, namely:-

**Amendment of** section 11 of West **Pakistan** Ordinance XI of 1960.

- "(f) funds held by or on behalf of the institution, immediately before the said date.".
- In the Principal Ordinance, in clause (a) of sub-section (2) Amendment of 8. of section 17, for the words "Government servants", the words section 17 of "persons serving in the institution" shall be substituted.
