SINDH ORDINANCE NO. IX OF 2002

THE SINDH COTTON CONTROL (AMENDMENT) ORDINANCE, 2002.

[26th March, 2002]

An Ordinance to amend the Sindh Cotton Control Ordinance 1966.

WHEREAS it is expedient to amend the Sindh Cotton Control Preamble. Ordinance 1966, in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly stands dissolved in pursuance of the proclamation of the fourteenth day of October, 1999, and the Provisional Constitution Order No. 1 of 1999:

AND WHEREAS the Governor of Sindh is satisfied that the circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No. 9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

(1) This Ordinance may be called the Sindh Cotton Control (Amendment) Short title and 1. Ordinance, 2002.

- (2) It shall come into force at once.
- In the Sindh Cotton Control Ordinance 1966, hereinafter referred to as the Insertion of section 2. said Ordinance, after section 13, the following new section shall be inserted:-

"13-A. No Cotton shall be transported from one place to Ordinance XX of another in any manner or by means which may contaminate it.".

3. In the said Ordinance, in section 14, in sub-section (2), for the words "fifty rupees", the words "ten thousand rupees" and for the words "five hundred rupees" the words "twenty five thousand rupees" shall be substituted.

 - pre-cleaners and lint cleaners; (c)
 - (d) new ginning saws at the commencement of crop season every year;
