THE PRIVATE UNIVERSITIES AND EDUCATIONAL INSTITUTES LAWS (AMENDMENT) ORDINANCE, 2002.

[12TH October, 2002.]

AN ORDINANCE to amend certain laws relating to the Private Universities and Educational Institutes in force in the Province of Sindh.

WHEREAS it is expedient to amend laws relating to the Private Preamble. Universities and educational Institutes in force in the Province of Sindh, in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly stands dissolved in pursuance of the Proclamation of the fourteenth day of October, 1999, and the Provincial Constitution Order No. 1 of 1999.

AND WHEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action.

NOW, THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No. 9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

(1) This Ordinance may be called the Private universities and Educational Short title and 1. Institutes Laws (Amendment) Ordinance, 2002.

- (2) It shall come into force at once.
- 2. The laws specified in column 2 of the Schedule below are hereby amended to the extent and in the manner specified against them in column 3 thereof.
