SINDH ORDINANCE NO.III OF 1998

THE SINDH LOCAL GOVERNMENT (AMENDMENT) ORDINANCE, 1998

[13th March, 1998]

An Ordinance to amend the Sindh Local Government Ordinance, 1979.

WHEREAS it is expedient to amend the Sindh Local **Preamble**. Government Ordinance, 1979, in the manner hereinafter appearing;

AND WHEREAS The Provincial Assembly is not in session and the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Sindh Local **Short title and** Government (Amendment) Ordinance, 1998. **commencement**.

(2) It shall come into force at once.
