THE MEHRAN ENGINEERING AND TECHNOLOGY UNIVERSITY (AMENDMENT) ORDINANCE, 1986.

[30TH July ,1986.]

An ordinance to amend the Mehran University of Engineering and Technology Act, 1977.

WHEREAS it is expedient to amend the Mehran **Preamble**. University of Engineering and Technology Act, 1977, in the manner hereinafter appearing:

AND WHEREAS the Provincial Assembly is not in session and the Governor of Sind is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Sind is pleased to make and promulgate the following Ordinance:-

- 1. (1) This Ordinance may be called the Mehran **Short title and**Engineering and Technology University **commencement**.
