THE SINDH TOURIST GUIDES ACT, 2011.

[6th July, 2011]

An Act to provide for the regulation and control of the profession of tourist guides.

WHEREAS it is necessary and expedient to provide for **Preamble**. the regulation and control of the profession of tourist guides.

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Sindh Tourist Guides Short title, extent and commencement.
- (2) It extends to the whole of Province of Sindh and applies to all tourist guides wherever they may be.
 - (3) It shall come into force at once.
- 2. In this Act, unless there is anything repugnant in the **Definitions**. subject or context -
 - (a) "Committee" means the Tourist Guide Regulatory Committee set up by Government under section 3:
 - (b) "Government" means the Government of Sindh;
 - (c) "Licence" means a license issued under section 4;
 - (d) "prescribed" means prescribed by rules;
 - (e) "rules" means rules made under this Act; and
 - (f) "tourist guide" means a person licensed as such under section 4.
- 3. (1) As soon as may be after the commencement of this Act, Government shall set up committee to be known as the Tourist Guide Regulatory Committee consisting of a Chairman and such other members as Government may appoint.
- (2) The Chairman and other members of the Committee shall hold office during the pleasure of Government on such terms and conditions as Government may determine.

- The Committee shall perform the following (3)functions namely:-
 - (a) advise Government in the implementation of the provisions of this Act and the rules.
 - (b) assist Government in the preparation of the code of conduct for tourist guides; and
 - such other functions as are in consonance (C) with provisions of this Act and which Government may entrust to it.
- Any person operating or intending to operate as **Licensing of tourist** tourist guide shall apply to Government on the prescribed guides. form for grant of a licence.

- On receipt of an application under sub-section (1), Government may after holding the prescribed tests and on payment of the prescribed fee by the applicant, issue to the applicant, if he qualifies in such tests, a licence in the prescribed form.
- Government shall, maintain a register in which (3) the names and addresses of all tourist guides shall be entered.
- The licence shall, unless earlier suspended or (4) cancelled under section 6 remain valid for a period of three years and may be renewed after every three years in the prescribed manner on payment of the prescribed fee.
- 5. Government shall, in consultation with the Committee, Code of conduct. prescribe a code of conduct for tourist guides.
- Government may, after affording a tourist 6. (1) guide an opportunity of showing cause against the action proposed to be taken against him, suspend or cancel the licence of the tourist guide if he--

Suspension or cancellation of licence.

- (a) violates the terms and conditions of the licence; or
- (b) violates the code of conduct.

- (2) (a) A tourist guide aggrieved by the decision or order under sub-section (1) of an officer or authority other than Government may prefer an appeal to Government within the prescribed time and in the prescribed manner and the orders of Government in such appeal shall be final.
- (b) Government may at any time of its own motion or on an application of any tourist guide aggrieved by any decision or order passed by Government under this Act or the rules, within the prescribed time and in the prescribed manner, pass such order as it think fit:

Provided that no order against a tourist guide shall be passed unless he has been given an opportunity of showing cause against it and of being heard.

7. Except as otherwise provided in this Act, no person **Prohibition to act** shall hold himself out or act, as a tourist guide unless he holds as a tourist guide. a licence.

8. Government shall, from time to time by Service charges (1) notification in the official Gazette, fix the maximum rates of of tourist guides. charges to which a tourist guide shall be entitled for the services rendered by him.

- A tourist guide shall not demand from any person to whom he has rendered any service as such any amount in excess of the maximum charges fixed under subsection (1) for that service.
- The guides employed on a fixed salary on a whole time basis by any travel agency licensed under a law for the regulation and control of the profession of travel and tourist agencies shall not charge any fee from a tourist.

9. (1) Whoever

- (a) being a person to whom no licence has been issued; or
- being a person whose licence has been (b) cancelled or is for the time being suspended,

holds himself out or acts, as a tourist guide or otherwise contravenes the provisions of this Act or the rules or, being a tourist guide, contravenes the terms or conditions of the licence issued to him or of a notification issued under subsection (1) of section 8, or violates the prescribed code of conduct, shall be punishable with fine which may extend to five thousand rupees.

- Any Magistrate for the time being empowered (2)to try in a summary way the offences specified in sub-section (1) of section 260 of the Code of Criminal Procedure, 1898, may try summarily an offence punishable under this Act in accordance with the provisions of Chapter XXII of that code.
- No court shall take cognizance of an offence punishable under this Act except upon a complaint made in writing by or under the authority of Government.
- 10. Government may, by notification in the official **Delegation of** Gazette, direct that all or any of its powers under this Act shall, under such conditions, if any, as may be specified, be exercisable also by an officer or authority subordinate to Government.

Government may, by notification in the official Power to make (1) Gazette, make rules for carrying out the purposes of this Act.

- In particular, and without prejudice to the generality of the forgoing power, such rules may provide for all or any of the following matters, namely:
 - the fees payable for the issue and (a) renewal of a licence:
 - the form in which an application for a (b) licence is to be made:
 - the form of the licence; (C)
 - the code of conduct; and (d)
 - the conditions to which a licence shall be (e) subject.
