to amend the Sindh Letters of Administration
and Succession Certificates Act, 2021.

WHEREAS it is expedient to amend the Sindh Preamble.
Letters of Administration and Succession Certificates
Act, 2021, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Letters of Administration and Succession Certificates (Amendment) Act, 2025. Short title and commencement.
- (2) It shall come into force at once.
2. In the Sindh to amend the Sindh Letters of Administration and Succession Certificates Act, 2021, hereinafter referred to as the said Act, in section 2, in clause (b), the words "or where at least one of the legal heirs is minor" is omitted. Amendment of section 2 of Sindh Act No. VI of 2021.
3. In the said Act, in section 6 – Amendment of section 6 of Sindh Act No. VI of 2021.
- (i) in sub-section (1), for the words "legal counsel", the words "Power of Attorney" shall be substituted;
- (ii) in sub-section (3), in clause (b), after the words "identity cards", the words "juvenile identity cards or child registration certificate in case of minor legal heir and mental disability certificate in case of mentally disabled legal heir, issued from competent authorized officer" shall be added.
4. In the said Act, the existing provisions of section 7 shall be renumbered as sub-section (1) and thereafter the following new sub-section (2) shall be added:- Amendment of section 7 of Sindh Act No. VI of 2021.

"(2) The Letter of Administration and Succession Certificate issued in the case of minor or mentally disabled legal heir shall take effect and shall be executed after issuance of guardianship certificate of the person and property issued under the Guardian and Wards Act (Act VIII of 1890), of such minor or mentally disabled legal heir from competent court of law of his permanent residence to the extent of assets and share of such minor or disabled legal heir."
