**THE SINDH WATER MANAGEMENT (AMENDMENT) ACT, 2018**

to further amend the Sindh Water Management Ordinance, 2002.

WHEREAS it is expedient to amend the Sindh Water Management Preamble. Ordinance, 2002, for the purpose hereinafter appearing;

It is hereby enacted as follows:-

| 2. | In Section 30, sub-section (1) after the Clause (i) the following (i) shall be inserted:<br>“Two prominent women of the AWB command area in irrigated agriculture and water if available, preferably member of Board of Management of any FO” | Amendment in Section 30 of Sindh Water Management Ordinance No. XL of 2002. |
| 3. | In Section 42, sub-section (1), the following (1) shall be inserted:<br>“Two women of the FO command area, of one may be local UC member, in irrigated agriculture and water, provided that one woman member shall be landless.”              | Amendment in Section 42 of Sindh Water Management Ordinance No. XL of 2002. |
| 4. | In Section 56, sub-section (1), the following (1) shall be inserted:<br>“In addition to elected members of WCA, the Board of WCA shall consist of two women members preferably share croppers of same water course, where WCA is formed.      | Amendment in section 56 of Sindh Water Management Ordinance No. XL of 2002. |
| 5. | In Section 70, sub-section (i), for Clause (d) the following shall be substituted:<br>“Two women members, one shall be prominent women activist/lawyer/journalist and one shall be prominent women agriculturalist.                           | Amendment in Section 70 of Sindh Water Management Ordinance No. XL of 2002. |
