<p><b>An Act</b> to provide for regularization of the services of all categories of doctors appointed on contract or adhoc basis in the Health Department or working in its Projects, Programs and Health Facilities.</p>	
<p><b>AND WHEREAS</b> it is expedient to provide for regularization of the services of all categories of doctors appointed on contract or adhoc basis in the Health Department, Government of Sindh or its Regular Projects, Programs and Health Facilities, in the manner hereinafter appearing;</p>	<p><b>Preamble.</b></p>
<p>It is hereby enacted as follows:-</p>	
<p>1. (1) This Act may be called the Regularization of Doctors Appointed on Contract or Adhoc Basis Act, 2018.</p> <p>(2) It shall come into force at once.</p> <p>2. (1) In this Act, unless context otherwise requires –</p> <p>(a) “Act” means the Sindh Civil Servants Act,1973;</p> <p>(b) “appointment of a doctor on contract or adhoc” means the appointment of a duly qualified doctor made on contract or adhoc basis in the Health Department, Government of Sindh or its Projects, Programs and Health Facilities;</p> <p>(c) “civil servant” shall have the same meaning as assigned to it in the Act;</p> <p>(d) “Government” means the Government of Sindh.</p> <p>3.
